THE CITY OF JONESBORO, ILLINOIS A MUNICIPAL CORPORATION

A RESOLUTION VACATING CERTAIN ALLEYS IN THE CITY OF JONESBORO, ILLINOIS

THAT WHEREAS, the City of Jonesboro has identified an alley in the City of Jonesboro located in the James and Daniel Craver's addition to the City, that is Perpendicular to Market Street. Said alley that runs north and south between lots 2 and 3, 10 and 11, 14 and 15, 22 and 23 in the James and Daniel Craver's addition.

WHEREAS, the alley has not been in use for travel or maintained for several years with buildings and vegetation now blocking portions of said alley; and

WHEREAS, it has been determined that no public or private utility lines are situation in said ally such that its' closing will in no way adversely affect utility services to utility customers who receive services from the City of Jonesboro; and

WHEREAS, pursuant to 65 ILCS 5/11-91-1 of the Illinois Municipal code, the Jonesboro City Council has determined that continued existence and recognition of said alley by the City is no longer necessary as the same will never be needed for development as a street or for any other public purposes; and

WHEREAS, the Jonesboro City Council has also determined that the relief to the public of any further burden and responsibility of maintaining the to-be-vacated alley is in the public interest.

NOW THEREFORE, BE IT RESOLVED AS FOLLOWS:

Section 1. That the Jonesboro City Council shall hold a meeting on October 5, 2020 at 7:00 p.m. at Jonesboro City hall to allow for public comment in support or opposition of proceeding with the vacating of the Alley herein described as:

A strip of land thirteen (13) feet wide and approximately 310 feet long that runs north of and perpendicular to East Market Street, in Jonesboro, Illinois between lots 2 and 3, 10 and 11, 14 and 15, and 22 and 23 of James and Daniel Craver's addition to the City of Jonesboro, said alleyway running north and south situated in the County of Union and the State of Illinois. A map of which is attached hereto and incorporated herein.

<u>Section 2.</u> Notice by publication shall be made in the September 17th, 2020 edition of *The Gazette-Democrat*, in words and figures substantially as follows:

A Public Hearing on the Resolution of Vacating Certain Alleys in the City of Jonesboro, Illinois shall be held commencing at 7:00 o'clock p.m. on October 5, 2020, in the chambers of the City Council at the Jonesboro City Hall, 1101 Public Square, Jonesboro, Illinois, or in other location or by electronic means as provided by executive order of the Governor of the State of Illinois due to the COVID 19 Pandemic.

After such Hearing or any adjournment thereof, the Ordinance as presented or as revised after Public Hearing, shall be passed without any further inspection, notice, or hearing.

The proposed ordinance to vacate said alley, is available for public inspection on the bulletin board available in the public area in the Jonesboro City Hall, 1101 Public Square, Jonesboro, Illinois.

<u>Section 4.</u> This Resolution shall be effective upon its passage and adoption on September 8, 2020 and signing by the Mayor and the filing for record with the Jonesboro City Clerk.
