Under general supervision, performs technical building inspection and plans examining work to enforce compliance with building codes, regulations and ordinances; prepares project inspection reports; researches new construction materials and methods; and provides information to and works with the public to resolve problems to ensure code compliance. Administers multiple complex construction projects, assignments are general and of a continuing nature, requiring the exercise of independent judgment and initiative in scheduling, assigning and coordinating with other units, external contractors, and construction firms.

- Inspect and monitor a variety of construction projects during various stages of construction to ensure overall compliance with applicable codes, ordinances, regulations and safety standards
- Maintain project documentation through daily inspection reports, photographs, periodic progress reports on construction and installation work, create punchlists, and provide written feedback related to the findings.
- Confer with architects, contractors, builders and the general public in the field and office; explain and interpret building requirements and restrictions.
- Knowledge of Building, Electrical, Plumbing, Mechanical, Fire and general construction codes. Ability to prioritize, multi-task and meet deadlines.
- Ability to work cooperatively and effectively with the employees, clients, architects, engineers, contractors, the public, regulatory agencies, outside consultants, government agencies, and the general public.
- Keep abreast of current construction standards, codes, and regulations.
