## AMENDED ANNEXATION AGREEMENT

THAT, WHEREAS, by that certain instrument designated as Annexation Agreement, dated October 17, 1986, and recorded in the Office of Fort Bend County Clerk, under File No. 8654513, Deed Records of Fort Bend County, Texas, annexed into the Barrington Place Homeowners' Association those certain tracts and parcels therein described and referred to as:

All the lots in Barrington Place, Section IV, Subdivision, Fort Bend County, Texas, according to the Map or Plat thereof recorded on Slides 840A, 840B and 841A, in the Map Records of Fort Bend County, Texas:

WHEREAS, Eldridge Road Joint Venture, a Texas joint venture composed of E. R. LTD., a Texas limited partnership and General Homes Corporation, a Texas corporation, hereinafter referred to as "Declarant" is the owner of that certain property within the area contiguous to the property described as being encumbered in said Annexation Agreement;

WHEREAS, Eldridge Road Joint Venture, a Texas joint venture, has conveyed, transferred and assigned all of its rights, duties and obligations as Declarant to General Homes Corporation, a Texas corporation, hereinafter referred to as "Declarant".

WHEREAS, on the second page, first paragraph of the Annexation Agreement, recorded in Volume 1890, Page 2334, the File Number for the Declaration of Covenants, Conditions and Restrictions for Barrington Place, Section IV, Subdivision, was inadvertently and erroneously omitted from the Annexation Agreement and reads:

It is expressly understood and agreed that separate Restrictions have been filed for record for Barrington Place, Section IV, dated September 26, 1986 and recorded in the Office of Fort Bend County Clerk under File No.

Deed Records of Fort Bend County, Texas, which Restrictions, of course, will impress and subject the lots within Barrington Place, Section IV, to an annual maintenance and charge and assessment imposed hereby, and will make such subdivision subject to the jurisdiction of the Association.

NOW, THEREFORE, General Homes Corporation hereby amends the Annexation Agreement for the above described property to read:
