

2020 Bass Tournament Rules

- *One or two person teams.
- *Please have respect to other boats and give 100yd distance.
- *At blast off, wait behind power lines.
- *Disqualification for being late for your flight's weigh in time. No exceptions.
- *1lb deduction for each dead fish, including big fish contest.
- *1lb deduction for every minute late up to 5 minutes, after 5 minutes the team is disqualified.
- *All 2020 inland fishing regulations apply.
- *Tournament continues rain or shine.
- *No Refunds, no exceptions
- *No Pre-fishing on the lake on the day of tournament.
- *No trolling or live bait.
- *Only one rod and reel used at one time.
- *Five fish limit.
- *All fish must measure 14 inches with a golden ruler.
- *One team member must observe weigh in.
- *Total weight of fish determine the winner.
- *All ties for prizes will be split between all tying parties.
- *All live fish must be returned to the lake.
- *Entrants fish at own risk.
- *Tournament officials will not be held responsible for damage, loss of property, or life.
- *Tournament officials will have the final decision on all disputes.
- *All entrants must be signed in and paid by 6:00AM
- *Must be 18y/o to compete or 16y/o and accompanied by an adult.
- *Signing of the registration form to compete in the NC DARE Officers Association's 7th Annual "DARE to Fish" Bass Tournament also consents to a polygraph test administered at the discretion of the NCDOA board of directors or tournament organizers.
