The meeting was opened at 7:45 PM by President Chris Villa.

The Pledge of Allegiance was led by Bernie Walker.

A moment of silence was observed for armed services personnel, first responders, and past Federation members.

Committee Reports

Annual Dinner

Hunters Helping the Hungry

Penny Hickman reported that 3835 pounds of game meat has been distributed this program year so far. She stated that there are 2 volunteers that deliver most of the meat to the food kitchens.

Anthony Pittore asked that all volunteers using the butchering facility, to please clean up after each butchering session.

Conservation Education

Scott Emslie reported that he has received 9 applications for camp so far. He reminded the delegates that he needs to have applications in to him by January 1st in order to be in the drawing for the free Federation sponsorships. The DEC will open up the application process on Jan 26th.

Ken Rose stated that we will be stocking Morgan Lake later this month.

Club 36 Annual Raffle

The 3rd and final round of the 2019 Club 36 raffle drawings, including the grand prizes, was held at the end of the meeting.

Legislation

Bill Connors reported on several items:

- He received a letter from someone in Long Island about a mountain lion sighting. He determined it was fake news.
- He discussed the invasive Asian carp issue. These can have a large impact to the game fishery. There are plans under consideration to create a blockage on the Erie Canal to prevent the spread of the carp.
- He discussed the Bail Reform bill, which will go into effect January 1st. Our concern, amongst many, include the effect it will have on game law violations. Bill stated that it is getting a lot of attention in the upper levels of law enforcement. It could also have the adverse effect of law enforcement not even bothering to make arrests.

New York State Conservation Council

Bill Connors stated that the last Grass Roots Newsletter for 2019 was distributed.

A call for nominations from the floor was made 3 times.

A motion was made by Scott Emslie and seconded by Bill Connors that the secretary cast one ballot for the slate as presented. The motion was passed all-in-favor.

Upton Lake

Bill Connors provided a sample of a laminated access pass for folks to be able use our Upton Lake parking area property and lake rights. A parking sticker would also be provided. Persons must be in possession of the pass (and a valid NYS fishing license) and must park in the parking area, not on the roads. The pass must be presented to law enforcement upon request, and not landowners. The pass is free and good until revoked,

but at this point you must call Bill Conners at 845-635-1606 to obtain a pass. Signage will be posted at the site to this effect.

We have not yet received the list of complaints from the complainant or their lawyer. Without this documentation, we will not be able to determine if our remedy actions are the proper ones or if any more are needed. Regarding the right-of-way access to the lake shore, we have been using it since 1968. So there should be no issue to continue to use it to carry a boat down to the lake.

New Business

2020 Budget

Since no copies were available, Anthony read aloud the proposed budget for 2020. There is a projected deficit of \$1610. This is less than last year's budget, mainly due to not stocking fish in Upton Lake.

Upon a motion by Rich Poluzzi and a second by Tom Lasko, the proposed budget was passed. AIF.
