Included as a topic under this item are a discussion on a paper recently issued by the Washington Legal Foundation, authored by ANSI Board member Dr. William E. Kelly entitled "Resolving Standards Conflicts Key to U.S.-Europe Foreign Trade", provided as document IPC024-03. In addition to this paper is another recently released report from the Washington Legal Foundation, following up on a report issued earlier this year. This latest installment in WLF's educational Working Paper publication series, "Unscientific 'Precaution: Europe's Campaign to Erect New Foreign Trade Barriers", (provided as document IPC025-03) was written for WLF by international trade law expert Lawrence A. Kogan on behalf of the National Foreign Trade Council. Though no action is required, IPC members are encouraged to express their views on these papers.

¹ INCITS is the primary U.S. focus of standardization in the field of Information and Communications Technologies (ICT), encompassing storage, processing, transfer, display, management, organization, and retrieval of information. As such, INCITS also serves as ANSI's Technical Advisory Group for ISO/IEC Joint Technical Committee 1. JTC 1 is responsible for International standardization in the field of Information Technology.

The ANSI International Policy Committee (IPC) is responsible for: [1] the development of ANSI strategic directions and policies related to international and regional standardization in the broadest sense (not exclusive to ISO and IEC)[;] [2] general coordination and oversight of ANSI's implementation of the relevant initiatives (5 and 7) of the US National Standards Strategy - this includes coordination of the efforts of ANSI ISO Council, AIF, USNC Council, USNC TMC and the RSCs to ensure consistency/compatibility among them and advancement of the goals of the US NSS;[;] [3] management of relationships with standards and standards-related organizations other than ISO and IEC, such as ITU, regional European organizations, national standards organizations, etc. except as otherwise delegated by the ANSI Board of Directors to another body[;] [4] resolution of conflicting positions on issues of common concern to ISO and IEC - the IPC will make the final decisions on the common position to be submitted to both ISO and IEC when such conflicts exist[;] [5] coordination with the USTR on matters related to the WTO, FTAA and APEC SCSC, with the DoS on matters related to the ITU-T, and with other government agencies as appropriate.
