***Mountain Trail Challenge Clinic for Maryland American Quarter Horse Association
May 12 , 2018***

Registration, fees, payment: The clinic dates are May 12 , 2018. There will be a morning session from 10:00am - 1:00pm and an afternoon session from 2:00 - 5:00pm each day. Each session is \$130 and you are welcome to register for more than one session. Registration is due April 1, 2018, along with full payment. Make your check payable to Double C Farm, LLC and mail to the address above. All clinic sessions are limited to 8 riders.

Time: Come early so you and your horse are ready to start on time. Clinics run rain or shine so bring necessary gear for you & your horse. Bring your lunch, snacks and drinks each day.

Required for your horse: *A rope halter with a 12 - 14' lead line. It is suggested that your horse wear 4 tendon boots and bell boots during the clinic, and that you wear a helmet.*

* Each rider must provide a current negative Coggins at check in. If you are from out of state you must provide a current Health Certificate for your horse at check in.

Horse Care & Clean up after your Horse, etc: Cleaning up after your horse out by your trailer, no matter where your trailer is parked is your responsibility. Deposit all horse manure in the container near the barn, or trailer it back to your own farm. Bring your own water buckets, hay, muck bucket, fork, etc..

Personal pets: Please do not bring your dog or any other personal pet.

Auditors welcome & the fee is \$50 p/ person p/day. Bring a foldable chair if you need one.

All riders, auditors, children, spectators, guests and any other persons participating in and/ or observing the clinics are required to sign a release of liability and waiver form for the Double C Farm, LLC.
