Roberta Highland read the minutes of the meeting of December 20, 1983. D. L. Taylor moved the minutes be approved as read. Robert Norman seconded. MOTION CARRIED. MINUTES

Sam Taylor reported the good news that the leak in the lake had been found, and that it could be filled with cement. David Bretzke reported that he had discussed it with Larry Anderson, who agreed we should repair the leak in that way. Robert Norman moved we move quickly to repair the hole. D. L. Taylor seconded. David Bretzke reported that the Grapa-Growers Coop had requested a loan, and that the District will be applying for a Community Impact Board for a grant of \$80,000.00 to ex- GRANT tend irrigation water to the proposed Zimmerman Extension. After discussion, D. L. Taylor moved to apply for the grant from the Community Impact Board in the amount of \$80,000.00 to fund the Zimmerman Extension. George White seconded. MOTION CARRIED.

After discussion of pressure, and the system, and Mr. Beeman had stated he would not settle for anything less than a full year's irrigation water, George White moved we give Mr. Beeman a credit for one year's irrigation water. D. L. Taylor moved the District give the cheaper rate, even if more than one connection was used. George White seconded. MOTION CARRIED.

George White moved that Everett L. Schumaker be appointed to sign the signature card at the Bank. D. L. Taylor seconded. MOTION CARRIED.

David Bretzke reported that he had talked with Mark IRRIGATION Page, who stated that people who had not paid their 1983 irri- WATER FEES gation assessments should not receive water in 1984.

The Water Commissioner was discussed, and Dale re- WATER COMported that Mark Page and Bob Byrnes were working on their MISSIONER annual report. George White stated he thought it was a good idea to have a Water Commissioner, but not necessarily the same person. D. L. Taylor moved we approve the Moab Irrigation Company Letter authorizing additional points of diversion and that he would attend the Moab Irrigation Comapny Meeting. George White seconded the motion.
