 during this time.

Student and Faculty Survey Takeaways

- Potential survey biases reviewed. The survey was sent only through email.
- SMC NC website is an important resource for prospective students, as nearly half of them (47%) first learn about SMC through the website. Word-of-mouth is also a significant factor, with 38% of students hearing about SMC from others.
- Partner collaboration is essential to connect job seekers with career opportunities, as students primarily seek employment.
- Students would benefit from resources such as job search assistance, Wi-Fi access, and meal/food assistance.
- The demographic data review showed that the Santa Monica and Malibu communities are the primary areas served by SMC.

New Acute Care CNA Certificate Program

- This program is starting soon and is for current CNAs with 6 months of experience.
- The first cohort has a maximum of 20 students.
