IV. Old BUSINESS. Tim said he talked to Kevin about chip and seal parking lot at town hall and the cemetery, Bill asked if it was not done last year, Tim said only part of it, Asked about using cemetery bequest funds, for cemetery repair, Bill said he can give trustees a number soon,

V. Trustee Report: Jeffrey said he has one more meeting with Paris township about the fire district, out side of monthly community meeting at town hall. Bill asked if Jeff reviewed minutes so he can sign them.

VI. Department Reports.

A. Roads: We started putting asphalt down on Giddings. We have been mowing. We went out and mowed the intersection back on Giddings and Alliance roads. We had water leaking in the administration office. We have it fixed.

Park: park has been mowed. We put the last 4 benches in on field 4.

Cemetery: We have been mowing. We fixed a few graves. The foundations are poured.

Bill asked about the leak in the admin building as Beckwith had been called initially to repair, But was leaking worse. Bill asked if trustees still want to approve payment, since they did not fix it. But since Beckwith was not called back to fix, rather road department fixed, trustees said to pay it. \$155.

1518 will be going out the week of the 14 th for pump testing and
annual service along with replacing the cylinder for driver side dump shoot.
I will be out of town from 07/12/25-07/19/25. Capt. Grudowsky
will be in charge of the department.

Jeffrey brought up bill regarding bill from Country side. Bill said money is
appropriated for repair and maintenance, however, the trustees will still need to
approve, especially, if it needs to be reviewed, not regular maintenance.

Jeffrey made motion to pay countryside, seconded by Tim.

Bill reviewed that a PO is approved for Countryside, however, Trustees must approve
certain amounts, can't just spend because it is on po, what is the repair for. They are
responsible to review.

- C. Zoning:** Rhonda mentioned there was supposed to be a hearing, Monday for Keener
property, however, no one at township was notified, Bill said in past, letter came to
township from court, but there was none. It is postponed a month. Asked for pictures
from township. She may stop to ask if she can take pictures,

Approved variance a Kritch (sp) property, reviewed payments with Bill. Wrote
permit for pole barn, new construction on porter and Carlisle way. Chris asked about
Boat property, Rhonda said no responses, Schill as well.

Chris read **resolution 2025-017** to put renewal levy on the ballot in November, \$42.
For each \$100,000.00 valuation, 5 years starting collection in 2026, total \$129,941.00
per year.

Tim made motion, seconded by Chris, Jeffrey said he wanted to consider as a
replacement, Bill said there would not be enough time, as we would have to go back
and start over, We would not have public notice time to meet deadline for November
election, HB on replacement levy discussed.

present switches are old and the speed is not up to standard, Bill ordered one for road
and Admin building.

Jeffrey discussed Mitchell payment after he reviewed increased costs with Jesse, Bill said it was not just the base, other line items are higher than bid and quote is still within a month, Travel not included, Bill said they are nickel and diming us after approval.

Jeffrey made motion to pay Mitchell Bill, seconded by Tim.

Emily asked trustees for information regarding Jesse adding a time clock system at fire department. She is concerned how it might affect our payroll processing, Jeffrey said it should only report the hours, he will review with Jesse.

Jeffrey asked generally, how much would it cost the township to take out a 6 million dollar loan for fire department for building and Vehicles for 30 year period. Bill said you can find loan calculators on the internet, however, he would look at if the township could even afford the interest payment if not interest free loan. Would depend on the lender, or perhaps doing a bond, You can take a longer period sometimes. Bill said he would try to look at some numbers for next meeting. Emily said she could work it out, Tim said Without interest it is \$200,000 a year, Bill said we could not support that payment now, Auditor discussed that he had talked with her (Bethany), Jeffrey will follow up again. Need to identify time frames as well.
