# **CONVENED**

Ms. Basham seconded the motion which carried (4 ayes, 0 nays).

### LEDGER REPORTS

Ms. Hoot indicated that the city had received a check from Sam Houston Electric for the annual franchise fees in the amount of \$42, 177.74.

Mayor Wood reviewed the ledger reports.

Sales tax for the month was \$7,721.39.

Mayor Wood said the city is \$5,412.03 ahead of where we were last year in sales tax revenue.

Mr. Wulf asked for explanation of some of the expenses.

### **COMMENTS FROM ALDERMEN**

Mr. Pagel provided an updated list of Short Term Rentals for North Woods.

Mr. Pagel said there is a hole by the large culvert on Pine Street in North Woods that needs to be fixed.

Mr. Wulf said the potholes across from Dwayne's house on Edgewater Way are getting worse.

Mr. Smith arrived late to the meeting.

Mayor Wood said the Council would recess the meeting and go into Executive Session in accordance with Section 551.074 of the Texas Open Meetings Act. The meeting recessed into executive session at 7:05 p.m.

### **EXECUTIVE SESSION**

Ms. Basham made a motion to conclude the executive session.

Mr. Pagel seconded the motion which carried (5 ayes, 0 nays).

#### **RECONVENE**
