<u>Jeffrey McConnell</u> 5666 UU Road – I believe building a duplex falls into the category of moderate growth \*inaudible\* so I don't see a problem with it so I would hope that most of Fair Grove would be in favor of it. Thank you!

<u>Petty</u> – This rezoning request is to change 10 West Cherry from R-1 to R-2 for a duplex. There are no other duplexes on this street but there are other duplexes within a certain distance from this lot. Just for additional information since our Petitioner is not yet here.

Gwen Wilson, 24 West Cherry – I'm the immediate neighbor to the west of this property. I'm just concerned about the lot size, putting a duplex in is going to really overwhelm the lot size. I'm not necessarily pro or against but I'm just concerned what value that might do to my property having such proximity to my lot. Thank you!

Hodges – I had a question for you. Has that house really been nobody in it for a year or so?

Wilson – Yes.

Hodges – I mean, I was told that.

<u>Wilson</u> – I bought my property in November and I've always called it the abandoned house to my family and friends. So yes. Evan is doing a great job keeping the lawn mowed down. He's beating me on how fast he gets it done but no one's lived in it at least since I bought my house.

<u>Hodges</u> – Okay. That's what I was told. I was talking to some people and they said well nobodies living there and it's just running down maybe.

- 7. Carry out other work and activity as requested by Aldermen.
- 8. Review plans for construction, exterior alterations, reconstruction and demolition within the Historic Business District and to make written findings of fact and submit findings together with recommendations to the Aldermen.

<u>Petty</u> – First up for Planning and Zoning reappointments we have Mr. John Hayes whose term expires in September of 2025.

John Hayes – Thanks for inviting us tonight. So, just for the other Aldermen, I don't know if you shared this with everybody, Kelly. We went back and did some serious digging on the appointments and basically to get everything right, we are supposed to be renewed every 4 years. Out of everybody on the Board, there's basically only 3 of us that are in compliance right now. The other 3, I, myself, was supposed to be renewed by the Board of Aldermen in August 2022. That wasn't done so I was under the assumption at the time that it sort of auto renewed with the positions and it just wasn't taken care of. So basically, what I'm asking is for myself, Don Brite who was actually due to be renewed in September of 2023 and Travis Lee was due to be renewed in September of 2023 as well. So basically, I'm asking for myself and the other two to be renewed and obviously the only other application we've got which is for Dennis Roe. Thank you!

Petty - Thank you. Mr. Dennis Roe.

Dennis Roe – This is an original letter (attached) written July 3, 2017, introducing myself to the Board because I was new to the community then. I will just go through this quickly. I moved to Fair Grove in 2017. We actually bought our house in 2016 and my first summer in 2017 here, I met Roger Miller who was on the Park Board. He was giving away some playground equipment my wife was interested in so I went over to get it and we got to talking about the city. He was on the Park Board and in our discussion he brought up that there are openings for the city. I said well I'll look into that. Then I also met my neighbor, Steve Mallard, and he was serving as an Alderman. He encouraged me to look into openings in the city so I did apply for Planning and Zoning in July 2017. I started serving in August 2017. Fast forward to 2019, I took another step and ran for Alderman and no one ran against me and I won. Imagine that. So, I served 6 years as Alderman and one of the benefits of being previously Planning and Zoning and then Alderman was Aldermen has to assign a person to Planning and Zoning and they asked me and I said yes, I've already done that. So I finished my Alderman term so I cannot be on Planning and Zoning anymore so I've reapplied and here I am. I am very interested in continuing to serve on Planning and Zoning. I was very involved in the Fair Grove Comprehensive update. Our previous Mayor, Tommy Voorhis, he was very much aware of that. One of the things I like about Planning and Zoning is if you understand the codes and if you use Diamond Maps, which is a system that Steve Short was an expert of, it shows where all of the water and sewer lines are and we had a person, Darrell Link owned 10 acres off of Saddle Club and he wanted to divide it into two lots. Well he had problem getting sewer to it and I said, well, if you divide it off of Arabian Avenue, that connects to Walker Lane, you can get sewer to both lots. So it helped him move forward with that process so I kind of look at the big picture and come up with a solution if there is one and that helped him move forward. I just wanted to give that as an example of something that I've done. Any questions for me?

Stewart - No, sir.

Petty – Thank you, Dennis.

Roe - Thank you!

<u>Petty</u> – The third application we have is for Travis Lee who was not able to attend tonight but did send an email expressing his interest to join the Board or the Planning and Zoning Commission. Would you guys like for me to read it?

Stewart – I've read it.

<u>Cooke</u> – I think you should read it for everyone.

<u>Petty</u> – The first application we received is from Richard Icenhower who's on family vacation but he did write a letter to the Board. (Petty read attached letter)

Petty – Next we have Mike Bell. Brandon Wolf?

<u>Brandon Wolf</u> – I've been building residential homes in Fair Grove now for 10 years. I'm applying to be on this Board because my experience has been instances where interpretation of the code could be different from other people's interpretations of the code. Just in that situation I think that we need to have experienced people on this Board to handle those situations. I've been living here at 619 Larissa since 2018.

Petty - Any questions for Brandon? Thank you, sir! Lisa Chapman?

<u>Lisa Chapman</u> – I've lived here for 29 years. I've never served in our city. I've always wanted to so I think this would be a good opening and opportunity. I understand how important this Board is even though it's a minimal commitment as far as time like an Alderman. I don't have any

zoning experience. I'm a business owner in Ozark and I'm willing to put in the research and time when issues or if issues come to the Board. I was recommended, actually my husband was recommended and he wasn't interested so I said sure, I would be interested. I would appreciate your consideration. Do you have any questions?

Petty - Thank you! Jeffrey Danderson.

Jeffrey Danderson, 67 E. Walnut – I think everybody on the Board knows me here. I know about this Board, I know how it functions. I've known about this Board for decades. It's an important board. I think whoever's on this board needs to have a good approach about municipal law. Zoning for instance, that's what this board pertains to. When you find it under state statutes, it's under Planning and Zoning. I've been working with the city for my whole life pretty much, since I was about 30 and I've got the experience for it, I've got the know-how for it. I know the codes front and back. I'd appreciate you guys considering me for this. It's something that myself and ex-mayor Mr. Short have talked about frequently and often. The importance of this, I don't know if everybody understands what this Board does have the final say on but if they get pass this Board, it will go to a court of law. There's no way around it. It acts as a mini-court. You hire a court reporter, you swear people in, you have attorney's. It's quite the deal but the statute simply states that there are 4 things you can work off of and there's seven questions you have to address. It's something that, if it ever happened, I don't think they've met in 10 years, maybe longer, but when it does happen, it has to be done correctly and it has to be done right. You're going to need people with experience. Any questions for me?

<u>Cooke</u> – I do, Jeff. As someone that does have extensive history being on this Board, in your opinion, why have we previously not really engaged with a Board of Adjustment.

<u>Danderson</u> – The last Board of Adjustment that I was involved in, we put people on it, the Board of Aldermen doesn't have anything to do with the Board of Adjustment. They have no control over it, no say over it so it hasn't really been anything that the Board of Aldermen have even really worried about. I did know the board wasn't full, I've known for a while but there's been no volunteers for this board. This board has been sitting there wide open for years. The last person I knew was on it, he passed away in 2014. I couldn't tell you when the last issue was that they had. I've got no clue. I'm going to say over a decade ago. So to answer your question, Tim, that's why it's not been on the Board of Aldermen's radar. It's a state statute. I couldn't serve on it because I was on the Board so I couldn't do anything about it but I'm not on the Board anymore. I personally brought my application up and filled it out. It's something that I've thought about a long time ago. I just wasn't able to do it.

Cooke – Understood.

<u>Stewart</u> – The seven questions that you said that they're allowed to ask, where's that information at?

<u>Danderson</u> – State statute. It gives you the 4 things that the Board, Planning and Zoning can't even visit about and the 7 questions, there just there. Each person on the Board of Adjustment has to answer those questions, you have to give your reasoning for the answer to those questions and like I said, it's all court reported, everything. So when you're done you have approved an appeal, denied an appeal, whatever the Board of Adjustments does, those records go right to the court, they stay there. So whoever this decision making was for or against, if they choose to take it a step further I would imagine there are going to be subpoenas involved, I would imagine there's going to be all of this going on so that's where it stays. But it's stipulated in the statute's what you do and do not talk about. It's not like the Board of Aldermen. You can't deviate in any way, shape or form. You just have to go down the checklist. Anybody else?

Stewart – I appreciate that information.

<u>Hodges</u> – On this Board here and everything, once you guys make your decision, city council can not change it?

<u>Danderson</u> – It has nothing to do with the Board of Aldermen. Once it gets to the Board of Adjustments, the next place it would go is a court of law.

Hodges - Alright. That's what I thought already.

<u>Cooke</u> – Thanks, Jeff.

<u>Petty</u> – Do we have Steve Mallard here? Chris Goins I believe rescinded his application. Sawyer Padget also rescinded his application. Brady Dickens? Steve Short?

Steve Short — I'd like to start with my community involvement. I've served on the Fair Grove Senior Housing Board. I served on the Public Water Supply District Board. I've served on the Fair Grove School Board. I've served on some Greene County boards, the Greene County Dangerous Animal Board for two terms and that's if the health department says if a dog or another dangerous animal has to be euthanized, that's the last appeal or due process. Not a pretty board to be on because you're dealing with very emotional issues there. I am currently on the Greene County Senior Services Board and that's a board that has a \$3,000,000 budget through Greene County that our goal is to, by state statute, is to keep folks 60 years and older in their homes. I've served as Fair Grove Mayor for 4 years and a Fair Grove Alderman for 5 years. As Mayor I was on the Planning and Zoning Commission for 4 years. I've served as the Board of Alderman appointee and also I served on the Planning and Zoning Commission for one year as a citizen representative. As Jeff has stated, this is a very important board. It's a quasi-judicial by state statutes. All testimony is under oath by the city representatives and the plaintiff and if the city council does not agree with it, they can appeal to the Circuit Court as the same way as the

plaintiff can appeal to the Circuit Court. It is a quasi-judicial committee. Any questions? Thank you!

<u>Petty</u> – Dayna Ault rescinded her application. Ted Wolf? That is all of the applications that we have for Board of Adjustments.

<u>Hodges</u> – How about him?

<u>Petty</u> – He's not here tonight.

<u>Lord</u> – How many spots are on this Board, Mayor?

<u>Petty</u> – Five.

John Hayes – I just wanted to make sure that everybody on the Aldermen team knew, per Section 405.130, Section B regarding the Board of Adjustments, five members, you can have up to three alternates when you're choosing but since there's nobody currently on and all of these are new, one person has a one year term, second person has a two year, three year, four year, five year. Those are the five and they renew in five year increments. Just a point of order.

Stewart - Thank you.

<u>Petty</u> – Thank you. Alright, so we got one, two, three, four, five. We had five presentations either here tonight or through email. Those are Richard Icenhower, Brandon Wolf, Lisa Chapman, Jeffrey Danderson and Steve Short. Do you guys want to have further discussion or time to think about these applications before we approve any nominations?

# LEGACY LEARNING ACADEMY TAILS AND TRAILS (Cooke, Petty)

<u>Cooke</u> – So Tiffany brought this idea to me. It's quite intriguing. I've asked her to come today to provide more information, kind of discuss what it is that she's interested in doing within our community.

<u>Tiffany Hill</u> – The little people out here, they're all here in support of it. I should have brought them some marshmallows so I'll have to get them some. If you don't know, that's kind of our thing. I own Legacy Learning Academy here in town. Do I need to give the address? Okay, the

property address is 163 West Saddle Club and we are here to get our property that's right next to us which is 139 West Saddle Club and 121 West Saddle Club, I own both of those properties and they are zoned residential. We would like to move our Christian Academy, which is housed in the Legacy Learning Academy right now, we would like to move it into the house and then make an educational learning farm on that back 6 acres. So that's kind of our plan. In this packet that I just gave you, it will show you the property lines, our different phases that we would like to do, how we would like to zone the animals that we would have inside the property and then any potential problems with solutions for that.

<u>Cooke</u> – So this will, of course, have to go through Planning and Zoning initially but what are long range timelines for this? If it is approved, when would you be looking at beginning the project and such?

Hill – Well anybody who knows me knows I just kind of go for it when I get approval so my hope is to have the Phase 1 at least up and running by the school year start, so August. Which our Christian Academy just ended. Of course Legacy stays open year round but the Christian Academy just ended so that would probably be our first thing to transform the house into a one room schoolhouse and then we'll start working on acquiring animals. So probably start with chickens, small animals that aren't going to cause a lot of problems and they'll be zoned. We have a pond back there, I don't know if any of you know it's back there because it's so secluded with the Park on the back and the pasture on the one side and the tree line so you really can't even see back there but there is a pond that's back there now. We would love to expand that pond if possible, we know how ponds are, but open that up for fishing. So that's already in place, there's already a shed back there. The previous owners had animals back there. That would probably be our first thing is to start acquiring, hopefully through donations on some of the animals. Our future plan is to get to the point where we open this up for the community. We have field trips coming. Our kiddos that are in the Christian school will work with these animals. They'll learn skill sets that are important in life. They will open it up eventually, maybe on the weekends to do community events kind of like Ruttledge Wilson Farms and Gardener's over here. I don't have a pumpkin patch or a Christmas tree farm but hey, we might as well think big. Maybe we could bring some Christmas tree's in and let the community come in and buy a Christmas tree or pick out a pumpkin. But we really want it to be geared towards the littles. Obviously the littles are my passion and we just really want to do something for community that these little kids can come and do something with the family. If you look, I think it's towards the last page, is ideas for our monthly meeting, our monthly events. We might not be able to get a highland cow or a milking cow to stay there year round but we could have one come in once a month for maybe 6 weeks, if you all would allow it and then we teach these kids how to milk cows. Homesteading, those kinds of things, the beehive pajama. We have goats and pajamas. Everybody comes in your jamas and you hang out with goats in your jammies. We've got reindeer. That's a huge goal. Maybe reindeer in December where we could have events on the weekend where they come and families can just participate in this. So we want, the idea isn't that you just come one time and you're done, you pet a goat, you pet a sheep and you looked at some

chickens and you leave. The idea is to get these people to our community month after month after month which then helps the other businesses in town. Let's get these people here, let's get families here, let's get families staying here because it just helps us all in the long run. So that's kind of our future plans. Are there any questions?

Stewart – I love it and I will support it.

We're always open to suggestions. 2:00 in the morning is when I do a lot of my thinking so you can text me then. That's when I come up with stuff. Any other questions? The only thing for us is we would need to get it rezoned commercial instead of residential.

<u>Petty</u> – So you're asking for the city's support and guidance on the land use and zoning clarification which would go to Mr. John Hayes and Dennis and other members of the Planning and Zoning Commission so you could reach out to them to get on their agenda.

Petty – Within this, I would also like to put in some verbiage around order and behavior...

Petty - ...respect, so I think having clear guidelines for decorum and also relevance of the comments. So this would allow our citizens to be able to share their opinion and their feedback and important information that we, as Board of Aldermen, should know and be privy to prior to making our decisions. It will help us make more informed decisions and it could also build trust with our community and our civic leaders. Chief Riggin – A couple of things. I would like to look at your ordinances. I would like to look at the actual specific problem and the actual complaints. Because what one person sees as the issue, and we were talking about it before the meeting, when I was at Missouri State University we were charged with writing a bunch of motorists tickets. What I found was not 100% the pedestrians fault so you really have to hone in on it and it being a State route, you really want to hone in on what's the likelihood of MoDot coming in, they will want to do a study. So in other words, what I'm saying I want to do and what MoDot is inevitably going to do is do research first and find out where we can most aptly apply what enforcement actions we can do. So yes but it's not just a straight cut let's sit here. There are some things that we have to do.

<u>Petty</u> – Definitely. I think I would like to express the importance of this knowing we have students that cross there to get to school. The sidewalks were put in for accessibility and if it's truly a danger to use, the question is what can we do to minimize that risk.

<u>Riggin</u> – And when we do our research, MoDot loves to see that you've done your research, we've applied enforcement and then give them what that looks like because without that research, they're left to do it and they won't necessarily want to do it on their own.

Petty - Got it.

<u>Riggin</u> – They want to see that we've already established a solid problem based on fines, complaints and so on.

Chief Riggin — So I forwarded up the bids that you had requested, three of them. In the interim we've had a different scenario come about which seems to be typical in the care for the city of the citizens of Fair Grove. We had someone want to donate all of the money for all of the vests including shipping and everything. I showed him the specific exact vendor that I wanted to recommend and he agreed to it. I think as we've kind of talked off the record for some of this, it might be good to push this as a postponement to make sure this actually goes through and I think it will but as I thought and talked about it, it might be nice to postpone the final, us paying for it. I know this person, he's going to pay for it. He's already invested into the city well before I showed up so I think it's a done deal. <u>Petty</u> – So you would like a motion to postpone?

<u>Cooke</u> – Your preferred vendor is still the original one you presented, correct?

<u>Hodges</u> – This other one is much cheaper, isn't it, then everybody else? The PSP? PSU?

<u>Riggin</u> – The PSU is about moderate. There's one that's more expensive, one that's a lot cheaper but the turnaround time is longer and the quality on the third is just not good. The company that we have gone with has a....

John Hayes has put together a recommendation for changes to make to our Ordinance to be more in line with State statute. John, would you like to talk about your recommendations?

John Hayes - Basically with everything we went through, I'm just trying to put some of the onus back with the Aldermen, not with just the Mayor. The way that our current statutes are, it actually goes against some of the Missouri and County statutes in that, the way that it's currently written for Planning and Zoning is that the Mayor and only the Mayor can appoint to these various committees and so what I had sent to Kelly was basically the amended version basically says the Aldermen can consider all of the applicants and also make other recommendation in addition to and then vote on them as a group. That way you still have the same power you have as far as voting and approving the appointees but it's not just one person saying these are the only people I'm going to appoint and I don't want to hear anything else about it. It will also keep things on schedule going forward. I don't think we will get into as many conflicts with reappointing or renewing some of the committees going forward. Our committee with Planning and Zoning, the terms always expire in September so what you'll see going forward is probably me presenting something to the Aldermen team in August for the agenda saying these members are coming due, we need a consensus. What we don't want to do is fall out of quorum by having too few. We can actually have up to 15 members on Planning and Zoning and right now we basically have a minimum. If one or two people are absent or we don't have a Mayor that is joining in on the meetings, we could lose a quorum and that basically gives us a dead month. I think, Kelly, you had Sara draft the verbiage like you guys wanted?

Petty – I believe that we are at a really good point and time to engage with our public who I think has voiced the desire to be informed and included in their elective representatives business and the decisions that we are making on their behalf. In the past, the city has made the stance that there will be no Facebook, no social media representation, just our city website where we do have our agenda and minutes posted. We kind of dipped our toe into the social media ring with the bond issue by partnering with the school and the marketing class and using that as an advertising outlet to inform and educate the public on a ballot measure and what their vote means. So Tim, the President of the Public Relations Committee, newly appointed last month, and I discussed what it would look like for a social media page if the city were to have one. It would be just an information sharing place. It would be restricted to posts just by the approved city officials and/or delegates. Posts would be made and not be allowed to be commented on. We all know that Facebook can be a volatile, depending on the topic. We do not wish to engage in discourse through social media because it can be challenging and we know that decisions and opinions officially come from the Board, not just any single individual. What I have here, I have a sample welcome post, hopefully you guys have had a chance to read it. Basically just introducing to the public, here's our city Facebook page, this is what we're going to do with it. Some examples of information that we're going to post, types of content to be shared meeting agendas, minutes, notices, projects that we're working on, updates to those, operational changes so if City Hall is closed for a holiday. We can also open it up to our emergency services. If you guys would also like to have delegate access to post emergency police department information, fire department information, even thought I know technically you're not a part of the city but you could still, and you have your own Facebook page, but obviously the Emergency Management as well. Maybe that could be a feature, they could post what to do in certain weather scenarios. Crime prevention tips, sidewalk safety...

Riggin – Crosswalk safety, yeah.

<u>Petty</u> – Any city sponsored events like the community cleanup we just had. We could also have information for residents, so the sewer number to call, any bill changes, that's a hot topic. Job opportunities, permit deadlines, contact information. We can do features for our stellar city

workers, here's what they do, here's the impact they have on the city, here's how they serve you. We can do features for each of our Aldermen so they could get to know you. Fair Grove History, seasonal greetings...

Petty – For sure.

<u>Davis</u> – Yes. She does all of the Planning and Zoning stuff.

<u>Colton</u> – Depending on who's allowed to post and whatnot would it be setup in a certain way that, let's say Tim wanted to post something on the Facebook page, he gets approval from everyone else. <u>Petty</u> – So I think the direction that we've talked about is that I have access, Tim has access. We both have access to the page from our mobile devices through Facebook. I could make a post knowing that within these restrictive topics following all of the Sunshine Law requirements and knowing that this Board has entrusted me to respectively and correctly represent the City through the information that I'm putting out on Facebook, I would have access to that anywhere that I could log into Facebook.

#### POLICE DEPARTMENT

<u>Chief Riggin</u> — I'll be quick. Couple of things. There was a concern when the Board of Aldermen separated from our current law firm, what we would do with some of our charges and things, which nice to know our officers have bagged 3 DUI's in a week. I think it was 3 in just one week, two in the last couple of days so they're hitting it hard. I called and emailed Dan Patterson, our county prosecutor, and I will just read you what he said. Yes. In other words, can I submit charges to Greene County court if we have a City Ordinance and a State law that mirror each other and the answer is yes. I would venture to say that will be kind of a long term solution as well because some of our Ordinances, as I see them as the Chief, you know, they're ok, they're not back. We've got some really good stuff to work with, we really do. But there are sometimes a state charge is more appropriate and Dan Patterson is whole heartedly like go for it, send whatever you need for as long as you need. He is good to go so that was a big win I feel like on our part.

Petty – How is the cost compared to our...

Riggin – There is no cost...

<u>Lord</u> – So he's going to give is a prosecutor, he's going to loan us a prosecutor to prosecute those cases and he's not going to invoice us for that?

Riggin – Yep. We're going to send them in the same way everyone else does, the state charges, PC statement, offense sheet, throw it in and he'll assign wherever it needs to go. If it's traffic, it goes to their traffic prosecutor and so on and so forth. So, we're just going to work it like that right now. Now, that's not an ordinance, it's a state charge. If it's an ordinance then we have to wait until we get our attorney and they'll do it through the 31<sup>st</sup> Municipal Court. So we're going to try to ride this one and save a little bit of money. It's all about not making copies. That's a joke, she knows. I hate copy machines. It's just like burning money. The other thing is you had asked me to address this. This is something I knew about and I never thought it would come to this community and that is First Amendment Auditors. Really quickly, First Amendment Auditors are people that will come to public spaces to film. It most notably became an issue with police officers where they would film police officers and the officers would do the wrong thing, arrest them...

## Hodges - Wow.

Riggin - ...take their phones, so on and so forth. But now it's expanded to any public space to include city halls. It was our insurance that sent out an article that just really hit me loud and clear that we need to have a very simple policy that dictates where people can and can't go in this building. Cause there's nothing right now that if this door is open to this room during the day that a first amendment auditor couldn't come in and just sit here and film and do whatever they want. They probably wouldn't because they want to get a rise out of us employees so my recommendation is going to be to clearly denote employees only like our police door. Although you think you want people to come in, there's a lot of P.I.I. information that's in our mailboxes, I know my office and Sgt. Deckard's office that I don't want people to see. So we lock the door and invite people in, which is why we have that doorbell that actually works now. Tim had to use it today to get in. So that would be my recommendation. It's an easy lever to pull, it's an easy fix and the Courts are extremely clear. If you have a posted door and a locked door and someone tries to get in, they are now trespassing and you can arrest them outside of their First Amendment rights. They have no First Amendment right in space they don't belong in. So for example, this room, you could simply put a sign by appointment only, lock the doors, if the Library needs to use it, they have an appointment. A First Amendment Auditor could not film here. Now they could film in the lobby, they can film through the glass, that's fine. But they're not welcome beyond that inner lobby to where our employees are. I think that's important because, really quickly, I didn't think that would be a thing until I got a request for body cam footage from Chesterfield, Pennsylvania for a guy who does it for a living all over the country. Big cities, small cities and we got one. I'm thinking okay, so we can be on anyone's radar at any time. So I recommend that. I'm going to put some training together, I'm actually working on a lesson plan and those of us that work in this building are going to sit together for maybe 45 minutes and talk about what this looks like and how to mitigate if that were to occur. Because I am not of the belief that it can occur here. Prevention is worth all of the effort. Questions?

Petty – So just one note on the Chief's mention of doing education for all city employees including the police officers. I had asked him that when he finds these things that are relevant to more than just our officers, if he would be willing to include our other city employees in his instruction, in his in services. I do believe that it could be helpful for them as well. That was if Sara were to lead the instruction, she wouldn't have to do as much research to learn it and teach it but Mark who is our expert in these things, be the one to share this information. Chandra and Sara were good with that and Mark graciously agreed to do that, so thank you for including them. I think it might also be good to have Aldermen, if it's relevant to us, attend as well. I read the article and it's kind of scary what situation you could find yourself and not knowing what to do in that situation could tip you over and get you in trouble.

<u>Riggin</u> – That would apply to the school district on their own terms because there's rules for that as well. I will put some training together.

Stewart - To restrict these areas, does it have to be an Ordinance? A policy change?

<u>Riggin</u> – Just put a sign, employees only.

Stewart – Okay.

<u>Petty</u> – So you're going to put one on the inner lobby door and the outside door.

Riggin – Where Chan's door is. It already says...

Davis - No admittance.

Riggin - ... no admittance but I would like it more specific, employees only. And then on the back police door, employees only and then maybe a sign here that says by appointment only. So that you don't have people just coming in and thinking, cause this is really a special purpose room, special room for specific reasons, a special uses room and I think people need to know that. And you can dictate that. The courts were very clear on all of the case law I read. You, we as city employees, can dictate that for everybody's safety to include the First Amendment Auditors cause there's a lot of places that will arrest them, they'll get hurt, stuff like that and then the city will get sued because the cops didn't know what to do. But I will put that together and if you guys want to go through that, even getting together in separate spaces, I know that everybody together can create a quorum and then we might have a problem but we can work around that. I'm here all week. If there's no other questions, last thing I want to quickly do is one of the things that my officers and I talked about when I came here is number one, can we do real police work. But also the idea of how we reach out to the community and I want to highlight Officer Walters and one of the things she did. It was around the same time that I came in. This is important because you want to make sure that your officers are in touch with the community in such a way that we're problem solvers, not just hammers trying to solve a problem by hurting

people and throwing them in jail and writing tickets. There's a particular young man, we'll just call him R.B., in this community and R.B. comes from a pretty rough home. There's a lot of drug use, it's that story, right. Officer Walters happened to see him multiple times through the school and out on patrol one night, she just began talking to R.B., hey, what can I do to help. He expressed a lot of interest in doing something with his life, more than what he saw from his own experience and his family. So Officer Walters took the initiative to help hook R.B. up with a very prestigious Missouri State Highway Patrol Cadet program and they have like a week long camp coming up. She helped R.B. and the family get signed up for it. There's a huge process, he has to write letters, get letters of recommendation from the school, get letters of recommendation from other city people, her, she wrote one, Sgt. Deckard wrote one and it was a big process and R.B. and Officer Walters did it together with all of that help and he is formally accepted into the program and we're going to help mom with some of the gas cards that were so graciously donated to us by the same donor that's going to buy our vest and they're going to drive him up to this camp. That was my thing today. Give the cards to the family, if you have to take the time to drive them there yourself, do it and she agreed. She's going to go to the graduation on June 13<sup>th</sup>. But I really want to highlight this. That was her own initiative. That wasn't even a dictate. All I said was what does community policing look like to you for Fair Grove and that was her response. So I wanted to make sure you knew that because that wasn't a hammer, it wasn't a ticket and now the family looks at her as an officer in a totally different light and I know for a fact there have been issues and it was quickly resolved when Officer Walters could just show up. So I just wanted to highlight that and there will be more of that coming and stuff that I've seen. Just like I said with the DUI arrest in a week, week and a half. I mean, you can see that in Springfield but they're looking for it here now because I told them, this is your town that is the expectation and we don't want anyone hurt. And today was one of those deals. Somebody could have been hurt but Officer Deckard took care of it. Questions?

Stewart - That's real good to hear.

Riggin – It's better than crime stats, isn't it.

Petty – Super glad that you're here, Chief. Thank you!

<u>Petty</u> – That's fair. But I do have a few things that I want to report on. Recently the Public Works Committee got to go with Kenny down to the CC Lift Station to see the Titus Twister, which is an aerator and ozone diffuser into the pit to ultimately break up...

Hokanson – Grease

Petty - ...grease...

<u>Hokanson</u> – Rags.

<u>Petty</u> - ...and rags.

<u>Hokanson</u> – Easier to get a pump through.

<u>Petty</u> – It basically breaks everything up so there's not big chunks that break down the pumps. It also defuses ozone into the actual pit, which neutralizes hydrogen sulfite gas which is an immediate killer for any workers that may have to enter that pit. We are waiting on a formal quote but we will be including this in our proposal for our next years budget. Just FYI. Oh, Mark's got an interesting pamphlet on the Titus Twister if anybody wanted to take a look at it later. Kenny, your recommendation is 100% yes?

Hokanson – Oh absolutely. Yes.

Petty – I grilled the guy. I poked a bunch of holes in his presentation and his facts and he was able to back his stuff up so I do feel like this is something that the city would greatly benefit from. I think it would extend the life of the pumps in that lift station and I believe the sewer plant, down the line, would see the benefit of it as well.

<u>Hokanson</u> – And the manholes wouldn't have gas in them.

<u>Petty</u> – And the manholes to not have the gas, which is a very scary thing after I did some research on it. You can't smell it, it's an odorless gas that can kill you, right...

Hokanson - Quick.

<u>Petty</u> - ....like seconds. We don't want that. So it's going to be in our budget recommendation. I did sign the maintenance agreement with Fluid Equipment for our annual 11-point inspections and preventative maintenance and our bi-annual for our high volume Wastewater Treatment Plant and the CC-Lift Station and, or is it just those two?

Hokanson – Yeah, it's only those two.

Petty – Plant tour for the Public Works Committee is still pending. We got a potential tornado, we got washed out but the intent is still for us to go through and have our newest members tour the plant, see all the fun stuff, see how it all works. We meet weekly with Kenny, we get updates from him to get better understanding and knowledge of the sewer and the streets and sidewalks in the city, everything he does. He does a lot. Right now we're talking about mowing and this is just an extra ginormous project that's added on top of your already ginormous workload. So we are talking about what does it look like to get part-time seasonal help for mowing at the Wastewater Treatment Plant and that will probably be included in our budget recommendations too. Which we will be meeting with Larry tomorrow to talk about. Anything else from the Public Works committee? That's my update. Less eloquent, but.

Roe – It was very good.

Petty – Thanks.

<u>Hokanson</u> – You approve of that, Dennis?

<u>Roe</u> – Dennis approved.

<u>Petty</u> – He gave me two thumbs up. Do we have anything from the Emergency Services Committee? Human Resources? Park Advisory Committee? Public Relations? Planning and Zoning, Ben's not here. Finance, we're going to be meeting about our budget in the next couple of weeks.
