

On May 16, seven of us took a tour of the Scuttlebutt Brewery in Everett. Matt Stromberg, Head Brewer for Scuttlebutt took us on a tour through the brewery. He has been with the brewery for most of the 20 years the brewery has been in existence. Scuttlebutt beer uses only Northwest ingredients; barley from Vancouver, Washington; hops from the Yakima Valley; and most importantly a proprietary yeast from Odell, Oregon. With Matt's guidance, mixing all these ingredients together with some of the nation's finest drinking water from the Cascade Mountains and you end up with a quality product. The tour ended in the Taproom and we sampled several of their craft beers. They also make an excellent Root Beer.
