I provided a statement earlier that I stopped being contacted for more work after I reported to the FBI about the Talon Executive Services supervisor.

I stopped being contacted for more work after I reported to Talon Executive Services Director of Operations Kain Guercci and President Barry Mozian that my supervisor was trying to recruit me to work for an organization in Mexico that believed may have been a criminal organization. The Talon Executive Services supervisor's name was [REDACTED]. After Mr. [REDACTED] sent me encrypted emails containing sensitive U.S. Drug Enforcement Administration documents, I told Messrs. Guercci and Mozian that I had an obligation to inform law enforcement authorities. Messrs. Guercci and Mozian insisted that I do not go outside the company, I ignored their orders and reported everything to Los Angeles Federal Bureau of Investigation Special Agent Monica Cardenas via her cell phone and email Monica.Cardenas@ic.fbi.gov In February 2014, Mr. Mozian called me about their disappointment that people found out that I was a security guard for one of their clients, The Church of Scientology. He tried to get me to tell him that I gave critics of the Church confidential information and I denied it. He finished the call by threatening to sue me if they found out I told anyone where the Church's "secret" properties were. I responded that the "secret" properties are listed all over the Internet and protestors routinely came to protest in front of the guard-house all of us guards sat in everyday. This was the last communication I had with Talon Executive Services managers. I still continue to stay in touch with one of its supervisors, Manuel Alcaraz. I also stay in touch with a former Talon Executive Services guard who was partnered with almost all of the time, David Rodriguez.
