"**Order in the Court**" is designed both to improve public access to courts and make the courts system a proactive educator. The LCE will develop a **Justice Teacher Institute** where educators will receive substantive professional development on the structure and function of the state courts system, history of the Court and constitutional issues. The LCE will collaborate with the Louisiana Supreme Court and judicial organizations to develop an excellent curriculum for educators and for members of the judiciary to use when visiting classrooms. Program is funded by the **Louisiana Judicial Excellence Foundation** in the **Memory of H. Eustis Reilly**, a New Orleans civic and business leader.

Y-VOTE is a middle and high school youth education voting program in partnership with the **Louisiana Secretary of State** office. The program is designed to have
