# Public-private partnership plans development of Port Birmingham

Years of declining demand for coal in the Birmingham, Alabama, market led to declining shipments for Port Birmingham. In response, the recently formed Birmingham-Jefferson County Port Authority (BJCPA) and Watco Companies, LLC have entered into a public-private partnership to revitalize and repurpose the port.

"The idea is to take this old, coal-focused facility and repurpose it into something that is attractive, still to coal, but also to a new commodity base. We want to create Alabama's inland port," said Watco commercial manager KR McKenzie.

The current proposal outlines roughly a five-year plan. Phase I is currently in development and includes constructing a 50,000 square foot warehouse with overhead cranes, capable of storing weather-sensitive bulk and break bulk commodities. Future phases will continue to develop the port, making any necessary upgrades to the five barge docks and rail and truck access infrastructure, and create additional storage capacity and industry-specific build outs. Eventually, they plan for further developments along the Birmingham Terminal Railway.

The 184-acre Port Birmingham has one-half mile of frontage on the Black Warrior River, part of the Tenn-Tom Waterway, just a few miles west of Birmingham, Ala. It long served as a coal and steel hub for the area. As the market changed, it became clear that Port Birmingham needed to change as well.

As the waterways continue to expand their capacities, Port Birmingham is in a good position to secure container on barge service as Alabama's container trade is expected to grow substantially in the next 12 to 18 months.

Watco Companies, based in Pittsburg, Kansas, is the parent company of the BHRR. The BHRR is the short line railroad that connects the port to Class I railroads BNSF, CSX Transportation, and Norfolk Southern. The company also provides transloading and other services at the port. They took over operations of both in 2012, and through local partnerships in the area, are making positive changes to Port Birmingham.

"We want to continue to grow our relationship with the BJCPA, and through that, Port Birmingham," McKenzie said. "This area will see the benefits through job creation and tax revenues, and we're going to end up with a more diversified port location in central Alabama."

Port Birmingham is located at 8250 Birmingport Road Mulga, Alabama.

The Association of American Railroads (AAR) filed comments with the U.S. Department of Transportation (USDOT) urging the agency to extend the same pro-innovation regulatory approach to private freight railroads that is afforded to highway vehicles. The filing, which also offers regulatory reform principles and calls for autonomous-vehicle technology to account for highway-rail grade crossings, is in response to USDOT's request for comment on its recent publication, "Preparing for the Future of Transportation: Automated Vehicles 3.0" ("AV 3.0").

## Norfolk Southern's relocation to Atlanta is official

Norfolk Southern confirmed Wednesday its plans to relocate from Virginia to Atlanta at a press conference at the State Capitol.

The company's move will lead to 850 new and relocated jobs to the city over the next several years, and retain some 2,000 existing corporate jobs in Midtown.

Norfolk Southern Chairman and CEO said in a news release the move to Atlanta will allow the Fortune 500 railroad to have all its decision-makers together when its new Midtown campus opens in 2021.

"Alignment, collaboration, and accountability are the hallmarks of Norfolk Southern's plan to transform this company and its culture. Our new headquarters in Atlanta advances these key elements of success," Squires said in a news release. "Our potential has always been great and now is greater still, as we bring together all of our headquarters functions into a single, integrated team."

The new headquarters campus at West Peachtree Street and Ponce de Leon Avenue will be developed by Atlanta-based Cousins Properties. Norfolk Southern recently was awarded nearly \$24 million in property tax breaks by Invest Atlanta, the city's development arm, and state tax credits could raise the value of incentives by millions more.


Gov. Nathan Deal called Georgia, a major transportation and innovation hub, "a fitting home for Norfolk Southern's new headquarters." Currently, 130 employees work at the 300,000-square-foot plant, which is expected to generate an estimated annual payroll of \$5 million.

"This announcement also reinforces Georgia's distinction as the Southeast's gateway to global commerce," he said. "We appreciate Norfolk Southern's significant investment in Fulton County and look forward to celebrating the company's future growth and continued success."

Norfolk Southern is Georgia's 21st Fortune 500 company.

# Georgia Pacific launches production at new \$100M Alabama facility

A Koch Industries Co. has wrapped up work on one of its plants in the Yellowhammer State.

Atlanta-based Georgia-Pacific launched production at its \$100 million lumber facility in Talladega.

The company's new facility will produce around 230 million board-feet of lumber per year. Georgia Pacific plans to extend the production to 300 million board-feet of lumber at this dual served location via CSX and NS in the near future.
