Agreement of Terms

PAYMENT OF FEES: (1) Place in class, camp or course is reserved ONLY with FULL payment of fees. Student may not attend until all fees owed are paid in full. (2) Fees will not be pro-rated for partial attendance or absences. (3) No refunds will be issued for missed days or absences. (4) A \$40.00 charge is assessed for each non-sufficient funds (NSF) check. Payment for a non-sufficient funds check must be made by credit card, cash, or money order. (6) I am fully responsible for all fees. In the event that any payments or fees due are not made, The Art Shack , Inc. shall be entitled to recover all costs of collection whether suit be brought or not, including interest at the maximum rate allowed by law and attorney's fees.

PARENTAL CONSENT: (1) If emergency medical care is deemed necessary and listed emergency contacts cannot be contacted, I authorize The Art Shack, Inc. staff to act on my behalf in granting permission for my child to receive emergency treatment.
