Trustee Gavenda:

- Clinton County Ambulance budget to be reviewed at next meeting.

Treasurer's Report:

- The general ledger for the period 10/01/20 12/10/20 was reviewed including checks #7010 -7058.
- General checking account balance: \$40,970.06.
- Tax account balance: \$62,911.81.
- Cemetery CD balance: \$8547.14.
- George moved to accept the treasurer's report, supported by Gavenda. MPC.

Clerk's Report:

- Year-to-date budget was reviewed.
- Conner moved to rescind the motion made on October 21, 2020, to reallocate \$2000.00 from other revenue to election supplies (\$1000) and capital outlay (\$1000); supported by George. MPC.
- Conner moved to make a budget amendment to increase miscellaneous revenue (acct. 671) by \$5000.00 and increase election supplies (acct. 262-752) by \$2000.00, election workers compensation (acct. 262-704) by \$1000.00, election maintenance (acct. 262-934) by \$500.00, and elections capital outlay (acct. 262-970) by \$1500.00; supported by Wardin. MPC. This motion was made to compensate for election grant money received.
- Conner made a motion to reallocate \$750.00 from cemetery equipment fee (acct. 567-928) to cemetery salary (acct. 567-704); supported by Winsor. MPC.
- November 3, 2020 election update:
 - 80% voter turnout which is up from 73% in 2016.
 - \circ 429 absentee voters which is up from 170 in 2016.
- Wardin moved to accept the clerk's report, supported by George. MPC.
