REORGANIZATION MEETING MINUTES

FEBRUARY 19, 2019

Chairman Chamberlain called the reorganization meeting of the Warren County (Pequest River) Municipal Utilities Authority to order at 7:30 P.M. The meeting was held at the Authority's Administration building located at 199 Foul Rift Road, Belvidere, New Jersey.

Everdina O'Connor was reappointed by the Warren County Freeholders. Chairman Chamberlain asked Mr. Tipton to administer the oath of office. She was congratulated on her reappointment.

Also, in attendance were: Steve Donati, P.E., Authority Engineer; Brian Tipton, Esq., Authority Legal Counsel; Daniel Olshefski, Authority Chief Financial Officer; Billy J. Wauhop, Authority Consultant; Kevin Shoudt, Authority Consultant; and Patricia Kaspereen, Administrative Assistant.

Chairman Chamberlain led everyone in the Pledge of Allegiance and then read the Introductory Statement.

REPORTS OF COMMITTEES

Finance Committee: On behalf of the Finance Committee, Mr. Piazza, who chairs the committee, thanked Mr. Olshefski, Mr. Francisco and their staff, for assisting the Authority in preparing the budget and administering our finances throughout the year. He also thanked Mr. Wauhop for his in-house engineering and keeping our expenses under budget, and his staff for some of the in-house fabrication and running the plants. Mr. Piazza reiterated comments made at our last meeting by Mr. Francisco, who summarized our cash position for last year. We had a cash balance of \$6.4 million, and although we had budgeted to use \$500,000 from our surplus, we only needed to use \$960. We realized 235% of non-operating revenues over what we had anticipated. He stated that everyone has done a great job and thanked everybody for all the work

that they have done. Chairman Chamberlain thanked Mr. Piazza and expressed his appreciation of all the efforts put forth by the Finance Committee. He also thanked Mr. Olshefski and Mr. Francisco for their outstanding work. Mr. Scott agreed with Mr. Piazza's statements and thanked Mr. Wauhop for all his guidance. The other members of the committee also agreed with Mr. Piazza's comments.

Personnel Committee: Chairman Chamberlain, who chairs the committee, said that it has been a busy year. There has been a lot of discussion in terms of deciding on a 5th operator, Mr. Wauhop's impending retirement and possible transition. The committee met with Mr. Wauhop prior to the Reorg meeting to discuss updating the Personnel Manual. We continue to stay busy and meet on an active basis and he expects this to continue this year as well. Other committee members agreed.

Insurance Committee: No report.

ELECTION OF OFFICERS

Chairman Chamberlain passed the gavel to Mr. Tipton to conduct the Election of Officers.

Mr. Tipton opened the nominations for chairperson.

Mr. Scott made a motion to repeat the same slate of officers as last year. Ms. O'Connor seconded. There were no further nominations. The motion passed unanimously on a roll call vote.

Mr. Tipton congratulated the officers and relinquished the gavel to Chairman Chamberlain.

Chairman Chamberlain thanked Mr. Tipton and fellow Board members for their continued support, and support of the other Officers. He is very proud of how things are conducted on this Board and looks forward to good things in 2019.

APPOINTMENT OF OFFICERS

General Counsel: Chairman Chamberlain presented a resolution to award a non-fair and open contract for professional services to Florio Perrucci Steinhardt & Cappelli, LLC, for legal services for the upcoming year.

Mr. Scott moved to adopt Resolution #19-04, awarding a non-fair and open contract for professional services to Florio Perrucci Steinhardt & Cappelli, LLC, for legal services from February 19, 2019 to February 18, 2020. Mr. Nyland seconded. The motion passed unanimously on a roll call vote.

Mr. Tipton thanked the Board.

Consulting Engineer: Chairman Chamberlain presented a resolution authorizing the award of a non-fair and open contract for professional engineering consulting services to CP Engineers,

WCMUA Reorg mtg. 2019 LLC for the upcoming year.

Mr. Scott moved to adopt Resolution #19-05, awarding a non-fair and open contract for professional engineering consulting services to CP Engineers, LLC, from February 20, 2019 to February 18, 2020. Mr. Piazza seconded. The motion passed unanimously on a roll call vote.

Chairman Chamberlain congratulated Mr. Tipton and Mr. Donati.

Mr. Donati thanked the Board for their continued confidence.

NEW BUSINESS

Finance Committee & Personnel Committee: Chairman Chamberlain asked if current committee members would like to serve on the same committees for another year in the same capacity, if no one objected. Hearing no objections, they all agreed. Those two committees were set for another year.

Insurance Committee: Chairman Chamberlain asked fellow Board members if anyone felt it necessary to continue having an Insurance Committee at this time, or is it okay to table the matter until necessary? After a brief discussion, it was the consensus of the Board to disband the Insurance Committee for this year

Chairman Chamberlain introduced a resolution for the appointment of the Authority's Public Agency Compliance Officer for 2019. Mr. Wauhop was our PACO for 2018 and has agreed to do so again for 2019.

Mr. Scott moved to adopt Resolution #19-06, authorizing the reappointment of Mr. Wauhop as the Authority's Public Agency Compliance Officer (PACO) for 2019. Ms. Napolitani seconded. All in favor, motion passed.

Lastly, Chairman Chamberlain introduced resolutions to establish a schedule of meeting dates and designation of the official newspapers.

Mr. Scott moved, and Ms. O'Connor seconded to adopt Resolution #19-07, establishing the schedule of meeting dates for 2019. All in favor, motion passed.

All regular meetings will be held on the third Tuesday of the month. All regular meetings will start at 7:30 p.m., with the exception of the December 2019 and February 2020 regular meetings, which will immediately follow the Annual Rate Hearing and Reorganization Meeting that will start at 7:30 p.m.

Mr. Niece moved, and Mr. Scott seconded to adopt Resolution #19-08, for designation of the Authority's official newspapers. The Board designated the *Star Gazette* as the Authority's official newspaper, and with *The Express Times*, as the two newspapers to receive notices of meetings. All in favor, motion carried.
