Affidavit for Corrected Certificate

PLEASE READ INSTRUCTION CAREFULLY

This form is to be used for the following:

- 1) If the original Registration Certificate was for a new registration and there are typographical and/or description errors made by ICAA
 - a) Submit original Registration Certificate with this Affidavit within thirty (30) days with corrections clearly marked on the certificate
 - b) No fee
 - c) Only Part I needs to be completed

- 2) If the original Registration Certificate was for a new registration and there are description errors due to photos submitted with the original application being unclear to make a proper description
 - a) Submit original Registration Certificate with this completed Affidavit within thirty (30) days
 - b) Submit a fee of \$10
 - c) Submit new photos as listed under Identification in Part II
 - d) Part I and Part II must be completed.

- 3) If the horse's description is no longer correct due to changes the horse has made with age or due to a solid horse coloring that can be advanced from Breeding Stock.
 - a) Submit original Registration Certificate with this completed Affidavit
 - b) Submit a fee of \$10
 - c) Submit current photos as listed under Identification in Part II (additional close-up photos may be required for horses advancing with marginal coat patterns)
 - d) Current photos will be compared to original pictures already on file with ICAA to confirm that this is the same horse.
 - e) Part I and Part II must be completed

Should your request for a new Registration Certificate, or photographs submitted, contain any discrepancy that would bring into question the identity of the horse, the Registrar may require additional photographs or inspection of the horse. If for any reason the ICAA cannot complete the new certificate, the ICAA shall retain the original Registration Certificate until such time as proper identification can be made. Fee may not be returned.

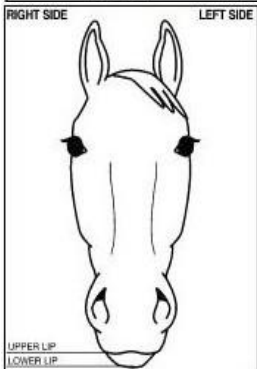
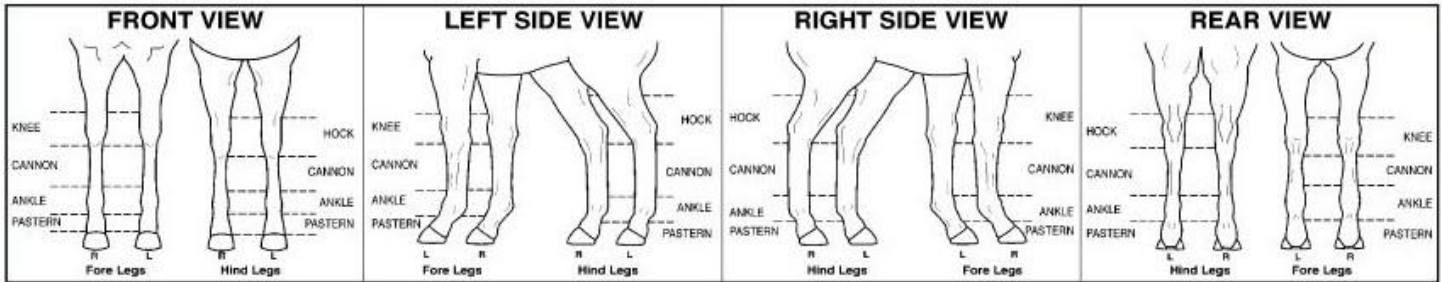

Identification

Please submit four photographs as follows: a full left side and a full right side showing the whole horse, and a full front and full rear shot with the forelock pushed aside to show face markings. All four legs should be clean and showing in each of these four photos, including hooves. Extra photos can be submitted where more close up details may be needed (and may be required). Photos are to be between 3 ½ x 3 ½ inches and 3 ½ x 5 inches with the horse filling most of the frame and without any body parts cut off. Label the back of each photo with the following: Date taken, horse's pending name, sex, sire and dam's name and numbers, owners name and membership number if known.

If a horse is carrying two dilution genes, please check off both colors above that apply.
 Example: A dunalino (dun/palomino) would have both red dun and palomino checked off.
