BCA General Membership Meeting February 6, 2020

The meeting opened at 7:35 pm with the Pledge of Allegiance

There were no minutes because Recording Secretary Ashley Davis was not present,

Treasurer Constance Pittas gave a brief review of the proposed budget. Numbers were revised upwards because of insurance and more committee expenses. Claudia Rotondo made a motion to accept which was seconded and the budget was passed unanimously.

Legislator Debra Mule introduced her new assistant, Jonathan Prevost as the point of contact for Baldwin. He is replacing Kiana Berria. The office number is the same.

President Darien Ward who sits on the LPC for the DRI said the project list has been emailed to all members.

- The next LPC meeting on 2/12 is postponed. There is a lack of TOD projects and the committee wanted more time for submissions. The proposals have been broken into three categories: Public Benefit, Commercial and Visual.
- Darien encouraged all to attend the meetings. Meeting time details are on the BCA and Town of Hempstead websites. Bob Hare also noted that he is posting details about the DRI on the American Legion FB Page which has been shared and has 900-200 views Darien stated it is not appropriate for the BCA to pick projects but encouraged people to attend meetings. Meta Mereday expressed concerns that there was 7 million dollars in just three projects. Also with items like the banners not all of Grand Avenue is in the DRI.
- Linda Deegan had a question about who proposed the BCA projects. Darien replied that members were asked for input and none was received. The project proposalss were written by Sam Cools and Rob Weisser. Linda questioned why not voted on by members. Rob stated they were not official proposals from the BCA. Also stated there was a meeting about proposals sponsored by the BCA and the Chamber at the library.
- There were also postonements due to change of town leadership and passage of zoning overlay.
- Bob Hare said three proposals have been cut. Some are fully formed and some in formation and some are just ideas.

Innovation 2020 – Meeting on March 3, Vote on March 18.

- Darien encouraged all to vote whether agree or not.
- Patrick Keating said there is a lack of info about this and the BCA should demand info.

 Darien asked Patrick to send his questions/request for info and he will pass to Dr. Camhi.

 Claudia Rotondo added that she believed you could submit questions through the website.

Kim Malone – Economic Development Chair – reported did a tech incubator walk through Karen Montalbano – Government Liaison – reported on writing an op ed about the Sunrise Highway property that appeared in the Baldwin Herald, going to Albany with the Long Island Lobby Coalition on February 25th and attended the Main Street Alliance meeting.

Darien talked about creating a scholarship in memory of Jason Vitale. Claudia made a motion to create the scholarship, seconded by Sam Cools. Passed unanimously.

Rob Weisser – Membership – planning monthly meetings, planning a membership drive in the spring and summer. Average of 100 members over the past few years. Aiming to double that.

Eggstravaganza is schedule for April 4th. Need volunteers to help. Also need people to help with fundraising.

Question from member about consolidating civics. Darien said this has been discussed at executive board meetings. While have similar concerns the organizations were started for different reasons. There are no concerns about having a joint meeting which Claudia Rotondo thought was an excellent idea to bring the community together. Representatives from the Baldwin Oaks Civic also thought it was a good idea

Darien brought up the idea of a Zoning Committee to be proactive on zoning issues. Meta Mereday noted the Nassau County Legislature was meeting at 7 pm on 2/24 Baldwin Oaks Civic Association representative Wayne asked about focusing on the car lots on Grand Avenue at Wesley and Joy Boulevard. Appears they have dealer's licenses but no variances.

Linda Deegan said she spoke with the landlord at the Best Buy Shopping center about the trucks there.

Bob Hare talked about two events – a Vets Expo on 2/10 at the coliseum and a St. Patrick's Days party at the American Legion on 3/14.

Claudia Rotondo made a motion to adjourn the meeting.
