

City of Log Cabin City Ordinance 97

AN ORDINANCE ANNEXING THE HEREINAFTER DESCRIBED TERRITORY TO THE CITY OF LOG CABIN, HENDERSON COUNTY, TEXAS AND EXTENDING THE BOUNDARY LIMITS OF SAID CITY SO AS TO INCLUDE SAID HEREINAFTER DESCRIBED PROPERTY WITHIN THE CITY LIMITS, AND GRANTING TO SAID TERRITORY AND TO ALL FUTURE INHABITANTS OF SAID PROPERTY ALL THE RIGHTS AND PRIVILEGES OF OTHER CITIZENS AND BINDING SAID FUTURE INHABITANTS BY ALL THE ACTS AND ORDINANCES OF THE SAID CITY.

WHEREAS, THE City Council has considered annexation of the following described property, to-wit:

ALL that certain tract of land including only a portion of the State Highway right-of-way of State Farm Road 3054 described more specifically as follows:

Beginning at a point where the present Log Cabin city limit boundary line intersects the said State Farm Road 3054 on the East side of the City and thence along a line a distance of one half mile East to Dixie Isle Private Subdivision Road Lagoon.

Thence South from the center point of the State Highway Farm Road 3054 for a distance of approximately one hundred and fifty feet to the South of said state highway right-of-way.

Thence North from the center point of the State Highway Farm Road 3054 for a distance of approximately one hundred and fifty feet to the North of said state highway right-of-way.

WHEREAS, said tract of land is contiguous and adjacent to the City of Log Cabin, Texas.

WHEREAS, after conducting hearings in consideration of such annexation as required by law, the city council has voted to annex said territory to the City of Log Cabin, Texas;

NOW THEREFORE, be it ordained by the City Council of the City of Log Cabin, Texas:

That the following described property, to-wit:

ALL that certain tract of land including only a portion of the State Highway right-of-way of State Farm Road 3054 described more specifically as follows:

Beginning at a point where the present Log Cabin city limit boundary line intersects the said State Farm Road 3054 on the East side of the City and thence along a line a distance of one half mile East to Dixie Isle Private Subdivision Road Lagoon.

Thence South from the center point of the State Highway Farm Road 3054 for a distance of approximately one hundred and fifty feet to the South of said state highway right-of-way.

Be and the same is hereby annexed to the City of Log Cabin, Henderson County, Texas, and that the boundary limits of the City of Log Cabin, Texas, and the same shall hereafter be included within the territorial limits of said City, and the said land the future inhabitants thereof shall hereafter be entitled to all rights and privileges of other citizens of the City of Log Cabin, Texas, and shall be bound by the acts and ordinances of said City.
