- f. Hess Mill Bridge Discussion the Township has applied for a grant for the replacement of this bridge and Supervisor Auerbach will present a timeline for moving forward with this project for discussion.
- g. Resolution 2020-08 –The state again is trying to pass House Bill 349 which would require townships to employ a minimum of two 3<sup>rd</sup> party building inspectors and allow contractors to choose their own. This issue came up once before and did not pass. A financial burden would be placed on the Township if the bill passes. Adopting Resolution 2020-08 would let Harrisburg know that Franklin Twp. officially opposes this bill.
