Everything will not happen overnight, but it will happen with everyone focused on the community's overall direction. Your Board encourages ongoing communication and participation to constantly improve the quality and harmony of our lives in the Hills of Neskowin. "Emailed information regarding activities and help needed would be beneficial. Advance notice is crucial if we want to schedule times to travel from our other home not in Neskowin Hills. We are happy to help in any way we can, but our opportunities are limited. Well done and thanks for asking!"

"When determining approval for new construction home site placement, the proposed utility and road layout for the subdivision should be considered. It is a useful guide to ensure each lot maintains it's ocean view."

"Property maintenance and seeing that bylaws are applied fairly is all I look for from the Board."

"Change landscape management, we do not trust Bros and Hoes."

"Would like to see consideration of new construction products that maintain aesthetic appearance while enhancing safety of the community (examples; cement roof shingles that look like cedar that are more flame retardant and easier to maintain. Also, metal roofs with appearance similar to architectural shingles."

"Many of our members take exceptional photographs of wildlife in our immediate area as well as local scenery and coastal shots.
