IMPORTANT INFORMATION FOR OUR CLIENTS ON MEDICAID (MEDICAL ASSISTANCE) AND FAMILY CARE

We are sending this memo out to all of the clients that we represented in handling your Medicaid application and renewals.

Since the beginning of COVID in 2020, the Medicaid program suspended all renewals. Also, nobody was taken off of Medicaid during this time period (unless the person passed away.)

The COVID procedures are now ending! In March, every Medicaid recipient will get a notice like the sample we have attached. The notice includes a date when the renewal will be processed. In the sample, the date is November 30, 2023. But the date in your notice could be a different month. Importantly, it might not be the same month that you used to have your renewal before COVID.

If your assets have increased past the allowable amount (\$2000 in most cases for single people and for institutionalized spouses after the first year) you will need to have them back down to the allowable level before the renewal. We can help you figure out the best way to accomplish this.

When you get the renewal notice, if we have been handling your renewals, please let us know right away and send us a copy. We will assume you want us to keep working on your case and will reach out if we get a copy of the notice too. But it is best if you tell us when you get your notice.

If you have been doing the renewals on your own but you would like to talk with us about this process or to have us handle this one, we can help.

You Need to Renew Your BadgerCare Plus or Medicaid by November 30,

2023

Note: Your notice could have a different date

When you are a member of BadgerCare Plus, Medicaid, or Family Planning Only Services, you must renew your benefits every 12 months. When you renew, we ask for current information about you and your household to make sure you still meet all program rules and are getting the right benefits. Because of temporary federal policies put in place for the COVID-19 pandemic, we have not asked you to renew since 2020.

You are getting this letter because the federal government is ending those temporary policies. **Your next renewal is due on November 30, 2023.** Your benefits will continue at least until that date.

You do not need to take action at this time. You will get a renewal packet in the mail a month before your renewal is due that will tell you what to do. Follow the instructions in that letter. If you move, be sure to tell us your new address. You can do this on the access.wisconsin.gov website or by using the MyACCESS smartphone app.

We will use the information you provide during your renewal to see if your health care benefits will continue. Please only take action to renew your benefits once you receive your renewal packet in the mail and before your renewal date of **November 30, 2023.** You must provide updated information when requested to stay in your program.

Note: the circled date may be different but the date is important!
