## SCHOLARSHIP APPLICATION

POSTMARK DEADLINES:

JUNE 30 FOR FALL TERM DECEMBER 1 FOR SPRING TERM (OFFICIAL TRANSCRIPTS DUE BY JANUARY 5) APPLY ONLINE – http://www.calistaeducation.org

The Calista Education and Culture, Inc. (CECI) Scholarship is funded by donations and fundraising through CECI. The scholarship program was established in 1994. CECI is an Alaska non-profit corporation, recognized by the IRS as a 501(c)(3) charitable organization and donors are eligible to receive tax deductible status on donations and gifts to CECI. All CECI scholarships are subject to the availability of funding.

#### ELIGIBILITY REQUIREMENTS

Calista Corporation Voting Shareholder or Descendant of an Original Shareholder: Applicant must be a Calista Corporation Voting Shareholder or Descendant (either natural born or legally adopted) of an Original Shareholder. Individuals who inherit or received gifted shares may not be Original Shareholders. Applicants must be Alaska Native and submit a copy of their Bureau of Indian Affairs (BIA) Certificate Degree of Indian Blood (CDIB) or Tribal Enrollment Documentation. Descendants must also submit a copy of their birth certificate.

High School Diploma or GED: Applicant must have a high school diploma or GED.

Grade Point Average (GPA): Applicant must have a cumulative GPA of 2.0 or higher. Most recent official transcripts from trade, vocational, college, or universities attended must be submitted, or official transcripts from graduating high school or copy of GED, if no post-secondary educational institution has been attended.

Letter of Acceptance/Good Standing or Proof of Application: Applicant must be accepted to an accredited school (trade, vocational, college, university) or provide proof of application. A letter of acceptance/good standing or letter from the school stating the application for admission is currently under review must be submitted. A letter of acceptance must be submitted if an applicant is awarded a scholarship.

Enrollment Status: Applicants must be enrolled Full-time or Part-time as noted below, based on the schools requirements. Trade/Vocational students must be enrolled in a degree seeking or certification program.

Full-time - undergraduate students must be enrolled in 12 or more credits. Graduate students must be enrolled in 9 or more credits.

Part-time - undergraduate students must be enrolled in 6-11 credits. Graduate students must be enrolled in 2-8 credits.

#### SCHOLARSHIP AWARDS

Scholarship awards are awarded on a Fall and Spring Term basis in alignment with the application deadline. The scholarship may be used for tuition, books, and fees. The scholarship recipient must have a 2.0 or higher GPA and maintain and satisfactorily complete a full-time or part-time status for the entire semester/guarter they received the scholarship.

Official Transcripts: Official transcripts from most recent trade, vocational, college or universities attended must be submitted, or official transcripts from graduating high school or copy of GED, if no post-secondary educational institution has been attended. Official transcripts must be in an envelope sealed from the school or submitted directly to CECI from the school. Copies of transcripts are considered unofficial and will not be accepted. Official transcripts must be submitted postmarked no later than June 30 for the Fall Term scholarship deadline and January 5 for the December 1 Spring Term scholarship deadline

Current Letter of Acceptance/Good Standing or Proof of Application: A current letter of acceptance/good standing or letter from the school stating the application for admission is currently under review must be submitted. A letter of acceptance must be submitted if an applicant is awarded a scholarship.

#### **CONTINUING** Applicant

Applicant is considered "Continuing" only if they have received a CECI Scholarship during the most recent Fall or Spring Term and completed all requirements outlined in the Agreement.

Application and Agreement Form – Due on June 30 for the Fall Term scholarship deadline and December 1 for the Spring Term scholarship deadline.

Official Transcripts: Official transcripts from the most recent Fall or Spring semester/quarter must be submitted. Official transcripts must be in an envelope sealed from the school or submitted directly to CECI from the school. Copies of transcripts are considered unofficial and will not be accepted. Official transcripts must be submitted postmarked no later than June 30 for the Fall Term scholarship deadline and January 5 for the December 1 Spring Term scholarship deadline.

#### APPLICATION PROCESSING

Completed applications must be received or postmarked on or before the deadline. LATE and INCOMPLETE applications will not be reviewed and considered, additional materials will be discarded, and submitted materials become the sole property of Calista Education and Culture, Inc. and cannot be returned. The stated deadline remains in effect whether the day falls on a weekend or a holiday. When Calista Education and Culture, Inc. receives more eligible applications than the available funding, meeting the minimum selection criteria does not guarantee funding at any level. Applicants are considered for the appropriate scholarship award based on the information they submit in their application. Applicant selection is made in the sole discretion of Calista Education and Culture, Inc. and not subject to appeal.
