

Terms & Conditions

TRAVEL PROTECTION PLAN:

The Travel Protection Plan is not included but is available and strongly recommended. There are three options:

1. Sign up for the insurance and pay the premium at the time you register for the tour and pre-existing condition waiver is included (refer to insurance flyer for details)
2. Sign up for the insurance anytime after you make your initial trip deposit and prior to the final date for trip registration and received the same travel insurance inclusions except the pre-existing waiver will not apply
3. Decline the Travel Protection Plan

The trip interruption and medical cancellation insurance premium is non-refundable unless the entire tour cancels. We offer a travel protection plan through Trip-Mate Insurance/a division of United States Fire Insurance Company Eatontown, NJ. Any surcharges and/or tax increases received suppliers for the package (airlines, cruise companies, hotels, etc.) may result in an increase in the per person price of your tour package. For those individuals who may have purchased the Travel Protection Plan this may also result in an increase in your Travel Protection Plan premium. Waiver of Pre-Existing Condition Exclusion. The exclusion for pre-existing conditional will be waived provided

- A. Your payment for this plan is received with your reservation

Visas/Passports: Holding valid travel documents is the responsibility of the traveller. A passport valid for six months beyond date of travel is required for entry into Canada and Alaska. Visa-exempt foreign nationals are expected to have an Electronic Travel Authorization (eTA) to fly to or transit through Canada. If you request an eTA you can apply for this online. Please discuss this with your travel agent or one of our specialists at the time of booking.

Itinerary

Day #1 July 3, 2024 - Arrival in Calgary

Our day begins with a transfer from your guaranteed departure point (Galena, Freeport or Rockford) to Chicago O'Hare Airport. Welcome to Alberta and the bustling city of Calgary! Once we've cleared Canadian Customs and Immigration, we'll meet our Tour Manager and board our private motorcoach for a relaxing drive to the city of Lethbridge. Our journey will take us south into the rolling plains of Southern Alberta known for its abundance of irrigated farmlands and specialty crops as well as its large cattle ranches and feedlots. Lethbridge is the financial, transportation, and industrial center of Southern Alberta. Tonight, relax and enjoy a special Western style Welcome Dinner.

Day #2 July 4, 2024 - Lethbridge

Today is a full day of exploring the agricultural heart of Lethbridge. Depending on the commercial schedules of our operators we'll spend time in "Feedlot Alley" and visit both beef cattle and sheep feedlots. We'll also take time to visit with some of the local farmers who grow a variety of crops including sugar beets, canola, potatoes, and pulses. We'll round out our day with a tour of one of the local greenhouse facilities.

Itinerary

Day #3 July 5, 2024 - Lethbridge – Bar U Ranch - Banff

As we depart from Lethbridge this morning we'll stop at nearby Fort Macleod to visit a replica of a fort built by the Northwest Mounted Police in the 1800s. We then head west through the Turner Valley, famous for its vast resources of oil and cattle ranching. We'll stop for a tour and lunch at the famous Bar U Ranch which was the largest ranch in all of Canada. A spectacular afternoon lies ahead as we travel north through the Kananaskis Valley, home of one of the largest Grizzly Bear populations in the country, and backdoor gateway to the Rocky Mountains. In the late afternoon, we will enter Banff National Park and the iconic resort of Banff. This evening, enjoy a spectacular view and dinner at the top of 7500 ft Sulphur Mountain. What a great introduction to the Canadian Rockies!

Day #4 July 6, 2024 - Icefields Parkway Sightseeing

A spectacular day lies ahead as we travel through the heart of the Rockies, along the famous Icefields Parkway. We are following a road that boasts endless presentations of azure blue lakes, rambling streams and rivers, glistening waterfalls, and glacier-topped mountains. At the summit of Bow Pass, we'll see the azure-blue waters of Peyto Lake and the rugged beauty of the Mistaya River Valley below. We reach the second summit and stop at the famous Columbia Icefields whose waters feed three oceans. Here, we'll experience a thrill of a lifetime – a ride on the Ice Explorer for a close look at the massive Athabasca Glacier. On the return journey, watch for wildlife including bear, moose, elk, and mountain goats. In the late afternoon, we'll arrive back in the alpine resort of Banff in time for dinner (on your own) in one of the many nearby cafes and restaurants.

Day #5 July 7, 2024 - Banff, Lake Louise, and the Calgary Stampede

This morning, we'll follow the banks of the Bow River to Lake Louise Village and wind our way up the scenic switchback road to the "Jewell or the Rockies", Lake Louise. Take some time to walk along the shores of the lake and view the majestic Victoria Glacier. Explore the shops and cafes of the iconic Fairmont Chateau Lake Louise. We'll return to Banff in time for some lunch (on your own), then view the spectacular Bow Falls before a mid-afternoon departure for Calgary.

We'll arrive at the World-Famous Calgary Stampede in time to explore some of the agricultural displays and buildings before sitting down to enjoy a delicious western buffet dinner. The fun continues with a series of championship heats of Chuck Wagon racing - excitement that's measured on the Richter scale! The excitement builds with the spectacular Grandstand Show featuring song, dance, and acrobatics and comes to a dazzling finale with a massive fireworks finale!


Day #6 July 8, 2024 - Calgary Touring & Stampede Experience
