

ORDINANCE NO. 1970-4

AN ORDINANCE ANNEXING TERRITORY TO THE TOWN OF CLOVERDALE, INDIANA

SECTION I: BE IT ORDAINED by the Board of Trustees of the Town of Cloverdale, Indiana, that the following described territory outside of the Town of Cloverdale, Indiana, but adjacent thereto and within the County of Putnam, be and the same is hereby annexed to and declared to be a part of said Town of Cloverdale, Indiana, to-wit:

A part of the northeast quarter of Section 1, Township 12 North, Range 4 West of the second principal meridian, more particularly described, to-wit:

Beginning at a point 786.55 feet South of and 1013.04 feet West of the Northeast corner of the Northeast quarter of said Section 1; thence South 1 degree 15 minutes East (adjoining deed South) 175 feet; thence West 125 feet; thence North 1 degree 15 minutes West 175 feet; thence East 125 feet to point of beginning, containing .502 of an acre, more or less.

SECTION II: That this ordinance shall be in full force and effect from and after its passage at approval of the Board of Trustees, and legal publication and notification according to law.
