

## How does the program work?

- **Submit your Sales Agreement** by fax or email, or electronically through our website, or simply call us to get started and your brochures will be shipped FREE!
- While waiting for your brochures to arrive, **we can create a personalized participant letter** including the details of your fundraiser such as why you are fundraising, your goals, payment options, when to turn in their orders, and whom to call if your participants have questions. The letter can also include a link your participants can share by email, texts, and social media for their family and friends to open and view the brochure. They can reply to the participant with their order and then pay by cash app, PayPal, mail a check, pay in person, etc. Customer checks, if accepted, are made payable to your organization.
- **Distribute your brochures and participant letter to your sellers.** Follow up with them throughout your sale to check on their progress and keep reminding them of your goal.
- Collect all brochures and payments at the end of your selling period. Complete a Master Order Form, fax or email the completed form, or call us and we can take the order by phone. An invoice will be emailed to you for the cost of your products plus \$50 shipping. Your first 5-8 items sold will cover the cost of shipping! Your organization will keep your brochures and profit upfront.
- **Pay for your purchase**. Payment by school/organization check, money order, cashiers, or certified check is required.
- A confirmation will be emailed to you once we receive payment. Once your payment has been received, your order will be submitted to our shipping department for processing, and you should receive your shipment in approximately 3 weeks. Orders are shipped by UPS. Large orders may be delivered by Common Carrier. You are welcome to email our office anytime for shipping updates and the estimated delivery date.
- **Report any missing or damaged items**. Seldom are there any missing or damaged items with our shipments. However, should any corrections be required, request a claim form within 72 hours and we will process a new order for the replacements.
- We'll provide coaching to help your campaign succeed, extended office hours Mon-Sun, 9 am 7 pm EST, and a solid commitment to process your order and needed replacements with no delay. When you require assistance, we'll be available to help you!
