#### **CHECK YOUR MAIL!**

We mailed out W-2s towards the end of January, so if you don't have it please call the office so that we can resend those to you!

### **PCS daily LIMITS**

According to State policy, up to twelve (12) hours of Personal Care Services (PCS) can be provided for every twenty-four (24) hour day for <u>ALL</u> workers combined. If your workers exceed 12 hours in a day, Life Patterns will call the Employer and inform them that they need to make an edit to their workers' hours.

#### **ECS daily LIMITS**

Enhanced Care Services (ECS) must be a minimum of 6 hours of sleep support within a 24 hour period. ECS is designed to provide supervision and/or non-nursing physical assistance during the Participant's sleep hours in his or her place of residence.

#### **Client Obligation Bill**

Legislation has been introduced to ELIMINATE the requirement for Client Obligations for HCBS Services in Kansas!

Your voice can make a difference, and we need to push legislatures so they can understand just how important this is!
