will be presented for discussion and input. All residents of the Village are urged to attend.

The Summer Village is required to hold Public Meetings to present some new and revised policies and bylaws. The plan is to present these at a PUBLIC HEARING at the Annual General Meeting on June 29, 2019. Residents will be given an opportunity to speak at that time, prior to final acceptance of the MDP and the LUB.

Stormwater Management Plan

As a result of overland flooding in the area last summer, the Summer Village has entered into an agreement with the Town of Elk Point and the County of St. Paul to develop:

Stormwater Management Plans

The project is being managed by the Summer Village and funded by a \$200,000 ACP-Alberta Community Partnership Grant. None of the municipalities have a stormwater management plan. The plan will address how to reduce challenges posed by overland drainage and flooding in the partnering municipalities.

The consultant hired to do the work will obtain observations from residents to aid in determining where flooding issues may have occurred & where areas with drainage problems' exist. Two (2) stakeholder workshops, for each corresponding plan, will be conducted with municipal staff as well as residents located within the study area.

MISCELLANEOUS NOTES

HIMALAYAN BALSAM

County of St. Paul Summer Students will be working around the Village this summer on the Himalayan Balsam eradication. Watch for them and make them welcome. At times, they may be working in some of the yards along the creek.

WASTE DISPOSAL

The waste bins located in the Summer Village are for BAGGED HOUSEHOLD GARBAGE ONLY. All other items for disposal should be taken to either the County land fill site on the south side of the lake or the land fill site at Mallaig. The garbage trucks will not take large items, so someone from the Village has to take them to the County land fill site. The waste disposal site is now being monitored by surveillance cameras.

BOTTLE RECYCLING

A reminder to please use the bottle/can recycling barrel at the waste bin site. The money raised from bottle recycling is used for Village events.

VILLAGE SPEED LIMITS

Speed limits in the Summer Village are <u>35 kph</u>, unless posted otherwise. This also applies to all motorized off-highway vehicles.

BEAVER DAMS

The Village is working with the County of St. Paul to solve the Beaver problem. The Beavers have built a dam at the north end of the little creek running into Vincent Lake. There is also a dam under the bridge on Horseshoe Bay Drive/TWP 594. There is considerable flooding and damage to trees.

DOG COMPLAINTS

Dogs in the Village MUST be kept on a leash or tiedup in your yard. Also, please do not let your dog do his business in your neighbors yard. The Village does not have a dog bylaw, therefore dog problems should be resolved between neighbors.
