Boarders picked up after 1 p.m. will be charged an additional \$15. No pickup or drop off on T-Day, Xmas Eve, or Xmas. _____

Please have your dog wear a collar or harness. ID tags are *strongly* recommended _____

Any dog left 10 days past their scheduled pick-up date becomes property of Deweydog's _____

Deweydog's Dog Etiquette Guidelines

It is important that your dog be healthy and display temperament characteristics that are conducive to a fun and safe environment for all. Deweydog's Staff will give dogs that "just aren't feeling it" breaks, in a comfortable, safe kennel or crate. _____

Please understand that Daycare is a lot like a kid's playground; accidents and scuffles DO happen. We screen our dogs very carefully here, but there is no way we can guarantee a 100% injury-free experience. Each and every owner is responsible for his or her dog alone; if your dog receives an injury that requires medical attention, you are responsible for the cost. _____

Deweydog's reserves the right to immediately change your dog's type of boarding/daycare if we believe it is necessary to protect the health and well-being of your dog, other dogs, or our staff. _____

If, in our judgment, your dog requires immediate medical care, and we are unable to reach you, we will take your dog to a veterinarian or animal hospital.
