

## AIRPORT NOISE

### The Phoenix Solution

This article is a synopsis of the presentation made by the LICIA Airport Noise Committee to Vice Mayor Ben Sorensen at the City-sponsored Airport Noise Meeting at City Hall on April 18<sup>th</sup>. This information had been shared with the Vice Mayor via email in the weeks preceding the meeting.

Note that after three years of working on this problem, it's not time to start over from scratch tonight discussing the technical issues of airport noise, such as "fifteen degrees of separation." There are plenty of resources for this information, including BCAD's website, the Part 150 website, and LICIA's Winter 2016 Newsletter article, "Everything you wanted to know about airport noise, but were afraid to ask."

How many times have we seen somebody post on Nextdoor: "We don't need a study to know that we have airport noise." The problem with that statement is that it's incomplete. We also have to say: "We have to do a study in order to do something about the noise." Why? Because the FAA says so. Like it or not, only the FAA runs the show when it comes to airport noise. Another thing we've said many times over the past three years: **"They didn't have a study before they changed the headings--- why do they need a study to change them back?"**

Here are some conclusions regarding the issue:

- Neither the County Commission nor the Broward County Aviation Department can do anything about the airport noise situation. The airport director can't just phone the control tower and tell them "stop using the 290 heading."

- Our county commissioner and BCAD will only say we have to wait for the Part 150 study run its course. Why? Because the FAA says the only way changes can be made for airport noise is by first conducting a Part 150 Study. And the FAA lays out the specific method for how the study should be conducted. The county is doing that and is paying \$2.5 million for it.

- Again, the only entity that can make any changes to flight procedures to help with the noise issue is the FAA. Not the County, not the City. Not even Congresswoman Lois Frankel, who sat on the House Transportation Committee.. And nobody, including Frankel, has been successful with the FAA on the issue.

So at this point, with the Part 150 proceeding, the City cannot do anything to bring about changes regarding airport noise, EXCEPT for one thing: Follow the City of Phoenix's lead

and engage the FAA in Federal Court. Phoenix was successful; other cities around the country are taking the same approach, including Washington DC.

Phoenix's success is the most significant development in the airport noise issue nationwide. Take a look at the article which we referenced in the Winter 2016 LICIA newsletter to see how airport noise lawsuits rarely, if ever, are successful. Until Phoenix, there has never been such an important and successful lawsuit against the FAA for airport noise.

A couple of notable points about the Phoenix case:

- The judges said the FAA was **"arbitrary and capricious"** when it changed the Phoenix flight paths without notifying the public and without seeking public input first. Think about this: how much notice did we – meaning Fort Lauderdale – get when the flight paths were changed here? It seems to us that the changes in headings here were "arbitrary and capricious" too.

- The FAA says the Phoenix case "did not set a precedent." Really? Several other cities are now pursuing the issue the same way Phoenix did.

The other recent significant event for us was the City election campaign for mayor and district commissioners this fall. Our Association made it clear at our candidate forums in August, November, and February – the primary issue in Lauderdale Isles is airport noise, and if you want our votes, you'd better commit that you're going to do something about it. At the February meeting, each candidate, with a little prodding, committed "unequivocally" to having the City pursue the "Phoenix Solution."

### The Part 150

We have concerns about the Part 150 Study: One of the issues that has arisen is that noise levels will be "averaged" in the noise contour maps that are being developed in the Study. Could that mean that the horrendous noise levels we experience in Lauderdale Isles will be averaged with the lower noise levels experienced by neighborhoods on the east side of the City? Would that result in lower, unrealistic "average" levels being displayed on the noise contour maps - in essence, making our noise levels appear to be not as horrendous as they are? Additionally, we have concerns about the accuracy of the flight tracks which are part of the inputted data of the Part 150 Noise Modeling software. Frequently, we see flights over our houses, halfway up our lanes. Yet when we request the flight tracks from BCAD, those tracks show the flights south of the river. (Note that BCAD is trying to address these track inaccuracies now). Another concern: we are told that as a result of the study, "maybe the 15 degrees of separation can be reduced to 7.5 degrees." Nope, we want 0 degrees of separation, in other words the original due west heading.

**Update on The Wave Streetcar** – The City Commission asked the City Auditor to review and tabulate all Wave expenses and also directed the City Attorney’s Office to research all legal options available to the City Commission. At this time, the Florida Department of Transportation (FDOT) has not received its final round of bids which should happen by the end of April.

**District 4 Volunteer Action Team** – We have so much we need to do as a city and I cannot do it myself – I need your help! Therefore, I am forming a District 4 Volunteer Action Team. This is open to all neighbors in the City. As an Action Team we will be communicating with neighbors about issues they have brought forward, ensuring those issues have been resolved and we will be working on shaping/planning priorities for the city. If you are interested, join us for lunch on Tuesday, May 29 at 12 PM in the 8<sup>th</sup> Floor Conference Room at City Hall. Please RSVP to MJ (contact info below).

**Neighbor Survey** – City consultant ETC Institute has published the results from our Fall 2017 Special Survey, which had 925 respondents. The full survey can be reviewed at <http://fortlauderdale.gov/home/showdocument?id=27498>. The purpose of the survey was to gather information in three areas that have traditionally received lower levels of satisfaction on the annual neighbor survey: traffic flow, homelessness, and public education. Major concerns associated with **homelessness** in the City were panhandling/begging and making neighbors feel uncomfortable in public places. On the issue of “How Often Homelessness is Observed in Fort Lauderdale,” 81% of our neighbors indicated they have observed homeless people in Downtown Fort Lauderdale almost daily. Eighty percent were “very supportive” or “supportive” of the City increasing enforcement of existing ordinances to prohibit panhandling. Neighbors support the City addressing homelessness by (1) providing grants to non-profit organizations, which provide services to the homeless, (2) developing new (and/or expanding existing) homeless shelters in the City, and (3) using an existing facility as a day center or transitional facility with homeless support services.

I am a founding member of Mission United of the United Way of Broward County, which has focused on reducing veteran homelessness in our city and helping military veterans and their families. As a member of the Advisory Board of the Salvation Army of Broward County and the County’s Continuum of Care Board, I am collaborating at all levels to leverage resources to provide permanent housing with support services to ensure the cycle of homelessness is broken.

On the survey issue of **traffic congestion**, poorly timed traffic signals and new development were considered the biggest contributors to this problem. Through the SE 17<sup>th</sup> Street Mobility Study, standing up a City Traffic Light Synchronization Task Force and working with the State and County, we are working on traffic congestion solutions.

On **public schools**, only 36% of neighbors indicated the ratings of elementary schools in Fort Lauderdale (grades K-5) were “excellent” or “good,” 19% thought the quality of middle schools (grades 6-8) was “excellent” or “good,” and 21% thought our public high schools (grades 9-12) were “excellent” or “good.” Across all grade levels, neighbors felt that public schools should have high quality teachers and that children should be kept safe from bullying. I am touring the schools in District 4 and meeting with Broward County School Board members. The City must do more to partner with our School Board to improve our schools.

As your new City Commission engages in its first annual Commission Prioritization Workshop on May 7 and 8, I expect this survey will help inform and guide some of our work going forward.

**FLL Airport Noise** – On April 18, we held a public meeting with other government officials to update our neighbors on progress to reduce noise levels from aircraft taking off and landing from Fort Lauderdale-Hollywood International Airport (FLL). I visited the air traffic control tower and have met with other agencies on this issue. In addition to having knowledgeable District 4 neighbors serve on the ongoing Part 150 FLL Noise Compatibility Planning Study, being conducted by Broward County (<http://www.flpart150.com>), we are exploring what measures other cities have taken to help address the problem.

**Solutions for SE 17<sup>th</sup> Street** – On March 26, I convened the 7<sup>th</sup> Meeting of the SE 17<sup>th</sup> Street Mobility Plan Working Group and I plan to continue leading this very important working group. At this most recent meeting, FDOT made a presentation on its proposal to add an additional lane onto the I-595 on-ramp from US 1. Our 8<sup>th</sup> meeting was on April 30, and the 9<sup>th</sup> Meeting is set for May 24 from 10 AM to noon in City Hall’s 8<sup>th</sup> Floor cafeteria. Additional Mobility Plan recommendations are to install wayfinding signage through the corridor, redesign the intersection of Eisenhower Boulevard and Grand Drive, and make changes to the development review and mitigation process.

**8<sup>th</sup> Annual Great American Beach Party** – Saturday, May 26, from 10 AM to 8:30 PM on Fort Lauderdale Beach near A1A and E Las Olas Boulevard. This free event will feature music, live performances, and activities for the entire family.

### Trees in the Water from Hurricane Irma

The process the City had to follow in order to get funding from FEMA for removal of fallen trees in the waterways looked like it was going to drag on forever. The complaints to the City kept coming in, so it was decided to have the City's Canal Cleaning

Department go out and remove the trees, with the hope that FEMA reimbursement funds could be secured some time in the future. Jim Grace and the Canal Cleaning Crew are the hardest working guys in the City. They worked diligently and finished removing the trees from Lauderdale Isles canals in April. When you see them coming down your canal performing their regular canal cleaning duties, be sure to give them a wave and a hearty "Thanks!"

### Blue Crab Testing

The Blue Crab testing we planned has been postponed temporarily, due to the untimely passing of Broward County's Laboratory Director, Nancy Craig.

### Derelict Boats

We continually receive complaints about derelict boats in Lauderdale Isles waterways. At our April meeting, it was decided to ask the LICIA Board of Directors if they wanted Code Enforcement to go out in a City boat to check for derelict boats, as was done several years ago. At the April 19th LICIA Board Meeting, the question was asked, and the Board unanimously voted "yes." The Board also requested that dilapidated docks be addressed at the same time. A request will be sent to the City to move forward on this issue.

### Manatee Sightings

We have reports of manatees still being sighted in Lauderdale Isles in late April. You can report them to the County's Manatee Monitoring Program, using their app "I Spy a Manatee." It's fun to do, and helps the County keep an eye on the "mermaids."



## The Phoenix Solution *Continued from Page 1*

With all of the above in mind, our Association's Airport Noise Committee presents the following 5 requests for the City:

1. Regarding the Part 150: Like the cities of Weston, Southwest Ranches, Hollywood, Davie, and Plantation, we want Fort Lauderdale to assign City staff to sit on the two committees for the Part 150 study. Currently the representatives for Fort Lauderdale are citizen volunteers. But the Town Manager for Davie sits on the Technical Committee for the Part 150. And the second committee, the Study Coordination Committee, which is supposed to provide information to the public as the study progresses, consists of staff members of the Public Information offices of Hollywood, Plantation and the other cities. Our members are volunteers. During the campaign, Ben Sorensen committed to us that our City's staff will join these committees, and that one of the city staff participating in the Part 150 will be him.

2. We want the City to follow the lead of Phoenix, and get the ball rolling on legal action against the FAA. As you know, on November 30th, Phoenix was successful. We recommend that our City Attorney reach out to the same law firm that represented Phoenix, as they are already well-versed in legal action against the FAA. Ben Sorensen and Dean Trantalis committed to this unequivocally at our February LICIA Candidates forum.

3. The City needs to hire an airport noise consultant to work on the case, to bring expert analysis and opinion, as opposed to our neighborhood volunteers - who are good, but are still only neophytes and only volunteers. As we move toward legal action, we need the expertise & knowledge of an airport noise consultant (Perhaps the law firm that handled Phoenix has such a consultant already).

4. Judging by participation in the Part 150 Public Workshops held last November, Lauderdale Isles and two neighborhoods northwest of us in Plantation had by and far the most attendees. We think the City should reach out to Plantation, meet with them, and get them involved in the legal battle as a partner.

5. City staff needs to be assigned the airport noise issue & need to keep us updated continually as things develop, like they do with those frequent bulletins we receive about infrastructure improvements. Additionally, City staff and City elected officials need to come out to the cul de sac on Key Largo Lane when winds are from the west, and actually hear the aircraft noise. To our knowledge, other than Winston Cannicle and Ted Baldwin from BCAD, and former candidate Walter Duke, we've never had any officials out to hear the noise first hand. They have to hear it to understand it.

In email exchanges, Vice Mayor Sorensen has said he is in agreement with these five requests.

### Along with the City, our goals are:

1. All westward departures use the original 275 heading on both runways and stagger the occasional simultaneous flights.
2. Departing planes cannot start any turns until they are set distance out from the runway, such as 1.5 miles or 3 miles.


We have asked Vice Mayor Sorensen to set up a meeting with him and the City Attorney to discuss how the "Phoenix Solution" should be approached by our City. He agreed, and the timing for that meeting will be determined soon. Also note that the Vice Mayor has jumped into this issue with both feet, and has already met with the airport tower manager to learn the technical aspects. *Thank you Vice Mayor Sorensen!*

Lastly- some have said: If this goes to court, the FAA's attorneys are going to say - and the judges may agree - "there is a Part 150 study underway now and we should all wait until that is completed." Our response is: what if the attorneys who represent us present our case properly - and the judges say:

**"They didn't have a study before they changed the headings - why do they need a study to change them back?"**

## INTRODUCTION


In 2017, the Broward County Aviation Department (BCAD) began a noise and land use compatibility study for Broward County’s Fort Lauderdale-Hollywood International Airport (FLL). This study is called a “Part 150 Study” because it follows the process outlined in Title 14 of the Code of Federal Regulations Part 150 (14 CFR Part 150), Airport Noise Compatibility Planning. This Study includes creating Noise Exposure Maps (NEMs) and a Noise Compatibility Program (NCP). The NEMs show community exposure to existing and future airport noise and identify uses that are considered “non-compatible”. The NCP recommends ways to reduce those non-compatible uses while preserving aviation safety and airport operational abilities.

## TECHNICAL COMMITTEE

The BCAD has formed a Technical Committee (TC) for the Part 150 Study at FLL. The TC is composed of stakeholder representatives who review study assumptions and provide feedback on the technical aspects of the study. These representatives include airlines, air cargo carriers, and local jurisdictions. TC meetings were held in May and August of 2017, as well as March 2018. Additional TC meeting dates for 2018 are pending, but will be listed on the Meetings section of the Study website at <http://www.fllpart150.com/meetings/>.

## PUBLIC WORKSHOPS

A series of five public workshops regarding the Part 150 Study were held in November 2017. Workshops were held in Southwest Ranches, Hollywood, Plantation, Davie, and Fort Lauderdale. Approximately 140 community members attended the workshops and provided 82 written and 17 verbal comments. More than 25 additional comments were received via the project website and mail. Common concerns noted among the comments received include: flights occurring during early morning and late night hours, flight path changes following the south runway opening, use of the south runway during nighttime hours, and the frequency in which flights are passing over certain areas.

## CURRENT PROJECT STATUS

The Part 150 Study team is meeting with local jurisdictions surrounding FLL as part of the land use data collection process. Concurrently, the study team is preparing inputs to the Aviation Environmental Design Tool (AEDT) – the Federal Aviation Administration’s (FAA’s) approved model for the evaluation of aircraft noise.

Current input items being evaluated by the study team include aircraft types, runway use, time of day for operations (daytime versus nighttime), flight tracks and runway utilization. It is anticipated that preliminary draft noise exposure contours will be presented in late Summer/Fall 2018. After the Noise Exposure Map (NEM) Report has been prepared, a public workshop will be held to present the findings to members of the community, currently anticipated to be held in late 2018.

Once the NEM phase is complete, the second phase of the study, the Noise Compatibility Program (NCP), will begin. The NCP will explore options to minimize aircraft noise exposure on non-compatible land uses surrounding FLL. Operational, land use, and administrative measures will be considered during this phase of the project. All recommended measures must be approved by the FAA prior to implementation at FLL.



## Isles Magical Mango Bread



2 cups all-purpose flour  
2 teaspoons baking soda  
1/2 teaspoon salt  
2 teaspoons ground cinnamon  
1/2 cup butter, softened  
1/2 cup vegetable oil  
1 1/2 cups white sugar  
3 eggs  
1 teaspoon vanilla extract  
3 cups peeled, seeded and chopped mango from Laud. Isles  
1/2 cup Golden raisins  
1/2 cup chopped walnuts or pecans  
1/2 cup shredded coconut

Preheat oven to 350 degrees. Lightly grease two 9x5 inch loaf pans.

### DIRECTIONS

- In a large bowl, sift together flour, baking soda, salt and cinnamon. In a large bowl, beat together the butter, oil and sugar until light and fluffy. Stir in the eggs one at a time, beating well with each addition, then stir in the vanilla. Blend this mixture into the flour mixture; just to combine. Fold in the mango, raisins, walnuts and coconut; mixing just enough to evenly combine.

- Let stand for 20 minutes then bake in preheated oven for 50 to 60 minutes or until a toothpick inserted into center of the loaf comes out clean. Goes great with mango daiquiris.
