Thank you for continuing to make our candidate forums such a huge success! Thank you to all of the candidates for their participation as well. We PCs, are tasked with making an impact in our communities, by being informed about our local, state and federal candidates. By you being informed, you are then able to share with those in your neighborhoods. PCs make a real difference by informing voters about the best candidates, which will in turn help keep our country true to its foundational freedoms.

This month at our July 14 th meeting, we will be holding an abbreviated forum for CD1, which has one seat open in the upcoming primary. Please note not everyone lives in CD1 so therefore you may have a different candidate running for the open position. LD3 also encompasses CD8, for which Debbie Lesko is the only Republican incumbent candidate running. Point of Information-Both CD1 and CD8 encompass other Legislative Districts, in addition to LD3.

We also will be hosting the Maricopa County Board of Supervisors, **District 2**, candidate forum. There is one BOS seat open in District 2, to be decided upon in the upcoming primary election. **Please note not everyone lives in County BOS**, **District 2, so therefore the open position may not be on your ballot. Go to** <u>https://www.maricopa.gov/224/Board-of-Supervisors</u> and click on district **locator box to find your district. You may also check your voter registration card.**

Thank you for participating in our straw polls. The candidates have found it very helpful. We will conduct another straw poll for the BOS, District 2 and CD1 candidates at the end of the evening and the count will be tallied at that time. Please note, PCs that live within BOS, District 2 and/or CD1 will be given a ticket upon check-in to vote in the straw polls. Some PCs may only be voting for CD1 candidate and some will be voting for both CD1 and BOS, District 2 candidate AND some PCs will not be voting in the straw polls at all. The results will be posted the following day after all candidates receive a personal notification.

I am including a job description for your convenience and to aid in your understanding of the positions. I am requesting for you to submit questions for both the congressional and the BOS forums to my email at <u>catherinetunget@gmail.com</u>. The deadline for question submission is on or before 7-7-22. The candidates will have a maximum 90 seconds for each question so please keep that in mind when you formulate your questions.

U.S. Congress: Members of Congress' powers are enumerated in one place: the United States Constitution. Under Article I of the Constitution, Section 2, the following are explicit congressional responsibilities • Making laws • Raising revenue, authorizing & amp; appropriating federal funds, and managing the federal debt • Providing for the common defense • Providing for the general welfare • Regulating commerce among the states and with foreign nations • Establishing the federal court system and defining federal crimes • Declaring war and maintaining and regulating the military • Directing a Census every ten years • Impeaching federal officers, including the President (House only) • Trying impeachments (Senate only) • Advising and consenting to treaties and

appointments of judges and federal officials (Senate only).

County Board of Supervisors: The County is governed by five elected district

supervisors. The BOS appoints a county manager. The Board sets the agenda and approves a budget that allocates money to all departments and elected offices. The county manager is the chief administrator of Maricopa County and oversees more than 40 appointed departments in carrying out the vision of the Board. The County Board of Supervisors oversees health, road, parks, libraries, law enforcement, and other municipal services. The Board also has the power to fill vacancies in the county and legislative offices, other boards and commissions, pass resolutions and enact ordinances and regulations as authorized by state law.
