DIRECTIONS;

From North: Take Hwy 99 South to Turlock. Exit Fulkerth, turn left (eastbound). The third stop light will be Golden State. Make a right on Golden State and then an immediate right on to North Front. Go approximately 2 blocks and make a right, cross the RR tracks, right on Broadway and enter through back gate.

From South: Take Hwy 99 North to Turlock. Exit Fulkerth, turn right (eastbound). Follow above directions.
