Update on Restitution Check for September

The amount received for restitution of property damage is \$161.90 for September.

Treasurer's Report

Mark Phillips and Jim Hampton

Mark Phillips stated he has spent many, many hours researching to provide an in-depth document that may be used in the future when applying for different type of funding match grants for the City. After discussions with many people and many agencies, he has provided several suggestions for ways to address issues with Pierpont Pond.

Jim Hampton addressed his possible role in providing assistance, such as contacts and content suggestions, for Flood Mitigation/Pre-Disaster grant funds.

Circle Drive Sinkhole

Mayor Mason announced the City of Lakeview Heights has been awarded \$15,600.00 from the Road Fund Co-op for sinkhole repair. This amount is 80% of the project estimate. The City will be responsible for the remaining 20% of the contract amount.

Building Inspector MOA Presentation and Discussion

Mayor Mason presented, to the Commission, an agreement proposal received from the City of Maysville for contracting a building inspector for the City. This document will need to be reviewed and a rate schedule established. After discussion, Commissioner Fluty made a motion to proceed with negotiations between the City of Maysville and the City of Lakeview Heights. The Commissioner's will review the draft proposal for discussion at a future meeting. Commissioner Camuel made a second to the motion and the motion carried.

Additional Business

Clerk Bolt informed the Commission of the readiness of property tax bills to be distributed in a timely manner.
