BYLAW NO. 4 - 2018

A BYLAW TO AMEND BYLAW NO. 7 – 2016, BEING A BYLAW OF THE TOWN OF PREECEVILLE TO REGULATE THE OPERATION OF VEHICLES

The Council of the Town of Preeceville in the Province of Saskatchewan enacts as follow:

1. Bylaw No. 7 – 2016 is amended in the manner hereinafter set forth.
2. Appendix 2 – “Yield” Streets, is added to as follows:
