

## Town of Baldwin, Maine SELECTMEN MEETING MINUTES TUESDAY, AUGUST 13th, 2019, 6:30 P.M.

**Attendance:** Selectmen: Dwight Warren, Jim Dolloff and Gerry Brown as well as members of the Public.

1. Selectmen Meeting was called to order approximately at 6:32 PM by Dwight Warren.

### 2. Review/ Approve meeting minutes

Dwight Warrent requested a motion to accept and approve July 30th, 2019 meeting minutes. Jim Dolloff made a motion, Gerry Brown seconded the motion; Selectmen voted 3-0 to approve meeting minutes.

### 3. Review/ Approve warrant

Dwight Warren requested a motion to accept and approve August 13th, 2019 warrant. Jim Dolloff made a motion, Gerry Brown seconded the motion; Selectmen voted 3-0 to approve the warrant.

#### **New Business**

- Code Enforcement Report: There is a boundary dispute with the Leo Buckley property. Is a civil case, not a town issue.
- Ben Thompson CCA: Discussion with Selectmen regarding abatement on a mobile home. If abated, needs to be adjusted with the auditors. Selectmen voted 3-0 to abate the trailer considering the situation, as it was removed and taxes were paid up to date. Selectmen discussed the tax commitment with Ben. Selectmen voted 3-0 and signed the commitment. The milrate agreed to for this year is 14.60.

- <u>Sand Pond Review:</u> Sherriff attended Sand Pond Meeting last night. Sherriff cannot enforce the town ordinances, as they are not a town officer. Best protocol is to call the Sherriff if wrongful behavior is witnessed on the beach.
