A live foal is guaranteed only to the extent of one return breeding the following year (the same or substitute mare), and then only by the initial owner of the contract. Any mare care charges, accidents, illness, or any mishaps concerning the mare named in this contract are the responsibility of the mare owner. A mare owner shall contact stallion owner/agent and be responsible for any and all charges/ fees related to execution of this contract. CNYRHA or NEBT is not responsible for any costs, expenses, or charges relative to execution of breeding contract by the breeding facility not contained or recorded in this contract. There will be no refunds. Donations will be sold at auction to the highest bidder; all starting bids will begin at \$500. Stallion owners will receive free entry into the Open or Non pro portion of the closed futurity if their stallion is sold.
