

# Voting Instructions for 2019 CIQMA

## Officers and Board of Directors

Voting instructions and ballots are posted on our website, [mini-indy.org](http://mini-indy.org) and on Facebook. One Vote per membership.

Ballots below may be printed now for your convenience. Ballots will also be available on Election Day.

### **Voting on Election Day – Saturday October 06<sup>th</sup> 2018**

**Where:** Near the line up boards

**When:** 9:30- 11:00AM – Voting for Officers only.

Results will be posted on Line- up Board and Announced at the end of the drivers and Handlers Meeting.

**Voting for Board begins immediately after Drivers and Handlers Meeting, closing at 2pm.**

### **Absentee Votes:**

- May be emailed to AJ Martin [ajmartinracing@yahoo.com](mailto:ajmartinracing@yahoo.com) with ABSENTEE VOTE in the subject line, but must be received by Oct 6<sup>th</sup>.
- May be mailed using the US Postal Service, to AJ Martin 1065 E. Main St. Brownsburg, IN 46112 and postmarked by Oct 4<sup>th</sup>.
- If the ballots are mailed, the name of the member must be on the envelope. These envelopes will remain sealed until votes are tallied. The envelope will be verified as being from an eligible membership. After it is verified, all three members of the NEC will initial the register for the mailed absentee ballot and place it in the voting box while still folded. This effort is being made to ensure voting anonymity.
- Please note, absentee ballots received WITHOUT A NAME will be void because we will be unable to verify it as eligible.
- We have carefully considered the options for Absentee Voters. If you vote for a person to fill both an officer and a board position, you do so knowing, if that person is elected into office the vote you cast for board will become null and void. To avoid a possible null and void vote you may chose to initiate your proxy.



Proxy:

- May be emailed to Teri Brinkman at [terbearfox@gmail.com](mailto:terbearfox@gmail.com) and must be received by October 6<sup>th</sup> 2018. Please put CIQMA PROXY in subject line and make sure your proxy includes both, your name and the name of the person you are giving the proxy.
- May be written and mailed using the US postal service to AJ Martin 1065 E. Main St. Brownsburg, IN 46112 if postmarked by October 4<sup>th</sup>.
- No proxy vote will be accepted unless we receive a formal notice from the person giving their proxy.
