Death of the Golden Goose

In one of Aesop's Fables, entitled "the Goose that Laid the Golden Eggs," a goose that had proven financially reliable over a period of time was sacrificed in order to provide an "imagined" short-term gain. .... Then Jeroboam and the whole congregation of Israel came and spoke to Rehoboam, saying, ⁴"Your father (David) made our yoke heavy; now therefore, lighten the burdensome service of your father, and his heavy yoke which he put on us, and we will serve you." ⁵So he said to them, "Depart for three days, then come back to me." And the people departed (1Kgs. 12:3b-5; Ed. note in parenthesis).

So Jeroboam and all the people came to Rehoboam the third day, as the king directed, saying, "Come back to me the third day."

13 Then the king answered the people roughly, and rejected the counsel which the elders had given him; 14 and (instead) he spoke to them according to the counsel of the young men, saying, "My father made your yoke heavy, but I will add to your yoke; my father chastised you with whips, but I will chastise you with scourges!" (1Kgs. 12:12-14; Ed. note in parenthesis; emphasis added).

This response was the last straw for ten of the twelve families in Israel. These ten declared their independence from King Rehoboam, who was based in Jerusalem, and they established their new headquarters to the north in Samaria.

Now when all Israel saw that the king did not listen to them, the people answered the king, saying: "What portion have we in David? We have no inheritance in the son of Jesse, To your tents, O Israel! Now, see to your own house, O David!" So Israel departed to their tents (1Kqs. 12:16).

By increasing taxes and creating more government combined with programs, burdensome regulations, the people of any nation are going to consider alternatives; just as ten of the twelve families in the ancient nation of Israel did by declaring their independence from the ruling class based in Jerusalem. This is the result that usually follows when leaders abuse their power and ignore a large portion of their population as we see happening in America today.

Jesus Christ made it crystal clear that any nation divided, as America is, cannot stand. Instead, it will tear itself apart while its enemies take advantage of this situation. If not corrected, any nation will collapse if it follows America's example.

But Jesus knew their thoughts, and said to them: "Every kingdom divided against itself is brought to desolation, and every city or house divided against itself will not stand" (Mt. 12:25; emphasis added).
