**Approval of Minutes:** Lisa motioned to approve the minutes of our annual meeting on February 4, 2025; 2<sup>nd</sup> by Ed Sanborn and the motion was unanimously approved. We will put forward an approval again formally at the 2026 annual meeting.

#### **Ed - Updates from President**

- Tampa HOA Expo
  - One vendor at expo had a portal product; will do an exploratory meeting /demo to learn more.
  - Few irrigation vendors in attendance.
  - o Met the vendor that installed our swing set; have brochure to review.
- CR1 Electrical Work for the Signs
  - All electrical work completed.
  - Received invoice from Brock Electric and forwarded to Duke Energy for reimbursement (\$3,600).
- Entrance beautification
  - Entrances need mulch, hedging lets look for volunteers.
  - Tree that was taken down, needs hole filled.
  - CR1 irrigation need to check to see if it's working.
  - Alt 19 irrigation not working.
  - We could consider soaking hose.
  - Longer term, we need to replace maybe with Florida type plants?
  - White pipes on entrance to Alt 19, what are they? Should we hide with shrubs?
- Swing set replacement
  - o Received bids from three vendors.
  - Current barrier zone is 40x20 and we need 32x28. Therefore we need 4 additional barriers (approx. \$200) and can be easily installed if we want to do ourselves.
  - WillyGoat \$7,169.31 (including approx. \$4k installation)
  - Playground Boss \$3,605.00 (will not install; they find local fencing co)
  - Creative Recreation \$6,667.02 (including approx. \$3k installation and \$240 for mulch)
  - Follow-up questions are they licensed and insured? What is the warranty? Confirm the swing set and installment meets state / county code.
  - We want to have a permit; what is the cost and process?

- Safety is paramount for our community.
- Removal of existing swing set Dave McGerald had an idea of repurposing wood from swing set to build a new picnic table. Dave will share sketches with the HOA that can be shared with Daventry.

  - Church took down trees several years ago on our side of fence; were supposed to install new trees which never happened
  - Not an immediate priority
- Ideas for reducing soliciting
  - o Inform solicitor that this is not permitted. Inform solicitor that soliciting is not permitted. Take business card and HOA Board can call and/or email company.
- Board admin session
  - o Working meeting to review roles and responsibilities. Review and access google drive.
  - April timeframe

#### Jeff - Updates from Treasurer

- Reviewed the financials (admin and common grounds) and vendor invoices.
- \$10k earmarked for tree vendor invoice and swing set. \$3,100 for trees; therefore \$6,900 left for swing set.
- Filing tax return.
