- 3. Community "Loaner Program" providing and maintaining such items as tables, chairs, canopies, etc. for CNRE property owners;
- 4. Purchase and maintenance of street Crime-Watch signs;
- 5. Operation of the "Good Samaritan" program by purchasing plants, gifts, cards, etc. for community members;
- 6. Community social events;
- 7. Production of requested community documents, i.e. telephone lists, plats, FAQ, CCR, Bylaws, etc;
- 8. Production of Newcomer Packages to new owners and potential buyers;
- 9. Provision of Pet Tags which are provided to members at no charge;
- 10. Production of 911 Signs, Cleanup Signs and Meeting Signs and maintenance of the existing Community Sign.
