Entries close at the Trial Secretary's home on WEDNESDAY, JUNE 7, 2017 unless the numerical limit is reached prior to the date after which time entries will not be accepted, cancelled, altered or substituted.

MAKE ALL CHECKS/MONEY ORDERS PAYABLE TO WWCDTC. Canadian exhibitors must make fees payable in U.S. funds. Exhibitors whose checks are returned for NSF will be assessed a \$20 service fee. Entries will not be accepted if received without signatures, fees and back fo entry form with agreement. An official American Kennel Člub entry form must be used. Telephone and telegraph entries cannot be accepted. No entry will be accepted which is made subject to conditions.

Bitches who come in season after the closing date will have the entry fee less \$5.00 refunded upon written certification by a licensed veterinarian to the effect that the bitch in question is in season on the day of the trial.
