Mayor Hight called the meeting to order at 6:00p.m. Terry Jackson gave the invocation.

Mayor Hight asked for approval of the Council Minutes from July 16, 2018.

Fire Chief Conner stated he has a 6 month plan for the Fire Department. He reported he would have Josh Parker over the Drill Field/Training and Zac Hamm over the Cadet program.

Council Member Littleton stated that the light at the Drill Field does not work all the time.

Terry Jackson reported to the council that Brady Barbee quit and he has hired Adam Bice to take his place. He explained Adam has CDL's and has worked with Asplundh for 30 years and wanted to get back home. He stated he would be riding the garbage route to learn it if Tony is out.

Mayor Hight reported to the council and gave them a copy of the 911 proposal for 2018/2019.
