# At this time coaches must submit the following information <u>ONLY</u>:

- 1. <u>Correctly spelled</u> ATHLETE'S First & Last NAME using the standard English language convention of an UPPER CASE LETTER at the start of the name and lower case letters for the remainder of the name. Please do not submit names in all upper case or all lower case.
- 2. GRADE IN SCHOOL -- Names submitted without grade in school

will not be entered in the data base and will not be considered a part of your roster! Double check your roster entry before sending it.

DO NOT enter events or seed performances AT THIS TIME!

Please do not submit your roster early and then make multiple additions or corrections. Please wait until you are very sure that it is relatively stable and unlikely to change much before the first meet.

# **REPEATED FOR EMPHASIS**

- 1. Your roster submission **MUST** include each athlete's <u>correctly spelled FIRST</u> name in the space for FIRST name, and the athlete's correctly spelled LAST name in the space for LAST name. Please use an upper case first letter and lower case after that. Please do not use all upper case letters or all lower case letters or any combination other than the standard English language convention for names. Please take the time and make the effort to do this correctly we do not have the time to correct careless mistakes!
- 2. Your roster submission MUST include each athlete's grade in school. Do not forget this piece of information or your athlete(s) will not be entered in the database.
- **3.** Submit your entry no later than 9:00PM, Saturday, December 6 or you will have no one participating in the first meet!
- 4. REMEMBER: entering your roster or weekly entries in your computer is not enough! You must **EXPORT** your roster in order for me to have it in my computer.

### 2025-26 PVIAC INDOOR TRACK SCHEDULE

Entry Limits: Four (4) athletes per event. No "B" relays. By PVIAC rule you may bring no more than 50 athletes to this meet. No non-competitors will be allowed into the facility. Order of Events: When events conflict, running events will take priority. Athletes excused from a field event must return before the conclusion of their flight in order to complete their attempts. A. Field Events:

- 1. High Jump- 2 pits-continuous flights of BOYS & GIRLS. If 1 pit only- BOYS →Girls in odd weeks, GIRLS → BOYS in even weeks. Odd week starting heights 3'08"/4'08" Even week starting heights 3'10"/4'10"
- 2. Long Jump- Odd weeks BOYS  $\Rightarrow$  GIRLS. Even weeks GIRLS  $\Rightarrow$  BOYS. Minimum measurable attempt (12'06" girls 16'06" boys). All first legal attempts measured.
- 3. Shot Put- Odd weeks GIRLS → BOYS. Even weeks BOYS → GIRLS. Minimum measurable attempt (20'06" girls 30'06" boys). All first legal attempts measured.

  B. Running Events: Girls followed by boys. 4. 2 Mile Run (cut-off @15:00.00 & 13:00.00) 5.

# January 26, 2026 (Sunday) Championship Meet

**Eligibility:** Athletes listed in the top 40 of the Track Central.net "Conference Best Performances" lists for each event will make up the "eligible pool". In running events (except relays) the top 24 declared athletes from the eligible pool will be taken into the meet. In field events the top 18 declared athletes from the eligible pool will be taken into the meet. In relay events the top 18 declared relay teams from the eligible pool will be taken into the meet. Ties for the final spot in all events will be accepted into the meet.

**Declarations (entries):** There will be **NO AUTOMATIC QUALIFERS FOR THIS MEET**. Coaches must declare, from the eligibility pool, their entries (with event qualifying performance) and submit it through *trackCentral.net* no later than 9PM, Wednesday, January 21.

Relays must be declared but individual team members do not have to be named until the day of the meet. Athletes may be declared in no more than three (3) events (including relays). **ABSOLUTELY NO LATE ENTRIES OR CHANGES AFTER THE DEADLINE.** 

**Notification of Acceptance:** Coaches will be e-mailed a final "Performance List" of the athletes accepted into the meet by January 23. Simply put, athletes not on the lists are not in the meet. **Challenges WILL be entertained by the Meet Director.** 

**Order of Events: (Rolling schedule in all events)** 

12:30 – 1:00 Warm-up period and National Anthem

1:00 - Boys LONG JUMP followed by Girls (trials and 9 to finals)

Girls SHOT PUT followed by Boys (trials and 9 to finals)

Girls / Boys HIGH JUMP run simultaneously (if only 1 pit available the event will be Girls followed by Boys. High Jumps open at the lowest qualifying height.

**BOYS WILL RUN FIRST** in all events except the 55m hurdle final). Running events will be clerked in the usual location.
