The **UNCENSORED** Gary Lynn McDuff Information Website



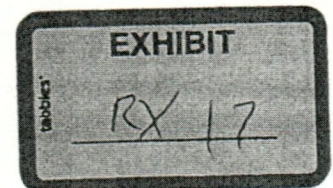

This website was designed by Kelly Dyer, at the request of Gary McDuff. To be fully transparent, this is the website to which Gary referred the persons he did business with. The Domain was purchased, and posted on the internet so anyone interested in Gary could read Gary's whole legal history, which was part of his resume' for every potential employer. It described, in detail, each prior conviction, incarceration, and even each arrest and trial that ended in acquittal. He did not "fail to disclose" the fact that he was a "felon". He published it. The website was published September, 2003, and remained on the internet through 2006, when the web-hosting company went out of business.

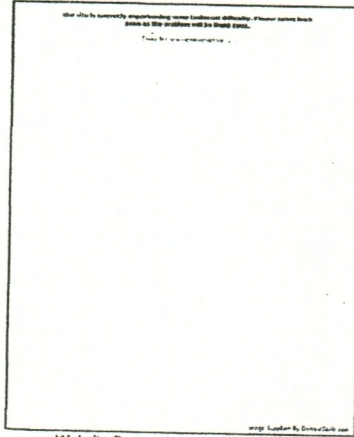

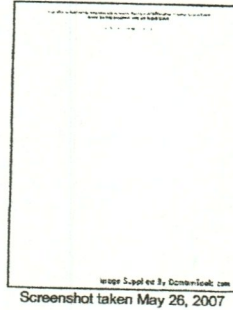

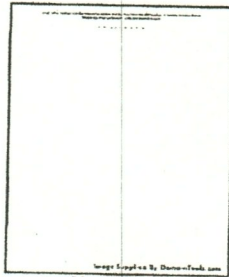




Screenshot History

DomainTools captures snapshots of website homepages on regular intervals. This content is useful for researchers to understand how a domain was used at various points in time. Due to the relatively high storage costs of screenshot data, the coverage of screenshot histories is in most cases not as thorough as Whois or hosting data, and this is especially true for dates early in a domain's history.

DomainTools has 2 records collected between May 25, 2006 and May 26, 2007.
