

CAPCIL Lip Sync Battle Rules & Regulations

1. Registration is open to the teams that complete and submit the registration form along with the \$25 entrance fee. Forms can be picked up and turned in at the Community Action Corporate office at 1800 5th Street in Lincoln or by visiting their website at www.capcil.info. The last day for registering for the event is February 24th, 2017 by 4 p.m.
2. Teams can range in size from 1 to 12 people. Eligible team members can include current CAPCIL customers, staff, and administration. All team member names must be included on the registration form. Only individuals listed on the registration form can perform.
3. Individuals can only compete in one act.
4. Voting will begin March 1st, 2017 on the CAPCIL website. 1 vote = \$1. The top 15 videos with the most votes will be asked to perform LIVE on March 24th at 7 p.m. Mandatory rehearsal will be held on Thursday March 23rd in the evening.
5. Teams may use props; these props must be included on the registration form to be approved by the CAPCIL Lip Sync Battle Committee. Props not included on registration form cannot be used in the performance. Fog machines, bubble machines, fire, water, and glitter are prohibited. Microphones will be provided.
6. Videos (YouTube link) and music (CD or USB) must be submitted by February 27, 2017 at 4 pm to be approved by the CAPCIL Lip Sync Battle Committee. Songs must be the clean version, no explicit versions will be accepted. Failure to submit video and music may result in the team's registration being cancelled. Teams will be notified by March 1st if the video and/or music provided is not approved.
7. The maximum time limit is four minutes per performance. After four minutes, the music will fade out.
8. The CAPCIL Lip Sync Battle Committee reserves the right to cancel registration if the committee feels the act is inappropriate or offensive to others. If an offensive act is performed, the CAPCIL Lip Sync Battle Committee reserves the right to terminate the performance and the act will be disqualified and registration fee will not be refunded.

The competition will be judged in these categories:

- A. Lip Sync Abilities: How well the performer(s) lip-sync the lyrics of the song.
- B. Creativity: How original and creative the performance is. Instead of just standing on stage and lip-syncing a song - props, choreography, costumes and/or other ideas should be used and often impresses the judges and generates crowd response. Be creative!
- C. Stage Presence & Choreography: Again, don't just stand there! Engage the audience, dance, smile, make eye contact with the judges...you're a STAR ---have fun!

Each category will be worth 15 points each. In case of a tie, the act with the highest lip sync score will win. The judges' decisions are final. Prizes will be awarded.

For teams that have a large number of participants, the 4 minute time limit may be slightly lengthened.

If for any reason, an act decides not to perform, the \$25 registration fee is non-refundable.

For family acts, children younger than 4th grade (and performing with parents) may participate.

Contest participants do not need to purchase tickets for the live performance. It is strongly recommended that family and friends purchase tickets in advance. Seating is limited!
