WHEREAS, the Town of Randolph is proposing the Town of Randolph Water System Improvements Project (Project), located in the Town of Randolph, Cattaraugus County, New York; and

WHEREAS, the Project has been classified as an "Unlisted Action" as defined by the State Environmental Quality Review Act (SEQRA); and

WHEREAS, the Town of Randolph completed a coordinated environmental review informing requested interested and involved agencies of the Town's desire to act as the Lead Agency; and

WHEREAS, the Town of Randolph Town Board has considered the significance of any potential environmental impacts per the SEQRA Regulations and completed the appropriate SEQR documentation for the project.

NOW, THEREFORE, BE IT RESOLVED, that the Town of Randolph Town Board hereby established itself as Lead Agency for the Project; and

BE IT FURTHER RESOLVED, that based on review of the SEQR documents, SEQR regulations, interested and involved agency comments, and other available supporting information, the Town Board hereby determines that the Project will not have a significant adverse impact on the environment and will not require the preparation of a Draft Environmental Impact Statement; and

BE IT FURTHER RESOLVED, that as a result of such findings, the Town Board hereby directs the Supervisor to sign the FEAF Part 3 of SEQR indicating that a Negative Declaration has been issued for the Project; and

BE IT FURTHER RESOLVED, that this resolution shall take effect immediately.

Resolved that the town schedule a public hearing August 13, 2025, at 7:30 P.M., for the purpose of conducting a public hearing on the proposed improvements to the Town of Randolph Water District within the Town, pursuant to Article 12-A of the Town Law.

The proposed improvements generally consist of various upgrades to the Town of Randolph's existing water system including water main replacement, locating and developing an additional groundwater source, booster pump station improvements, and various other water system improvements.

The maximum estimated cost of the proposed improvements is \$7,133,000. It is proposed that the cost of the project will be financed through grants and/or loans from various state and federal funding agencies including but not limited to the New York State Environmental Facilities Corporation (EFC) and New York State Home and Community Renewal Community Development Block Grant (CDBG).

A map, plan and report prepared by the Town's consulting engineers, which details the proposed improvements, including cost estimates and method of financing, is on file in the office of the Town Clerk, where it is available for public inspection during regular business hours.
