Bloomfield Police Department Monthly Report for June 2019

This is the monthly report for the Month of June 2019 from the Bloomfield Police Department. It is the police department's goal to keep the citizens of Bloomfield Township/Village informed as to the police department's activities, statistics, and community projects. It is very important that the citizens be aware of the various concerns that have and are occurring within our community.

On Monday, June $3^{\rm rd}$ at approximately 12:20pm officers received a theft from automobile complaint. The complainant reported that a set of golf clubs was taken from his vehicle while it was parked in a driveway located in the 1000 block of Violet Road. This complaint remains under investigation.

On Thursday, June 6th at approximately 9:45pm officers responded to a residence in the 1000 block of Maple Road for an assist to EMS request. While assisting EMS it was determined there had been a disturbance at the residence prior to the EMS request. At the conclusion a 35-year-old female was arrested then confined in the Walworth County Jail. A charge of disorderly conduct was forwarded to the Walworth County District Attorney's office.

On Thursday, June 13th at approximately 7:30pm officers responded to the 300 block N2020 Hwy H for a disorderly male complaint. At the conclusion of the investigation an 18-year-old male subject was issued a non-traffic citation for disorderly conduct.

On Sunday, June 16th at approximately 2:20pm officers received a disorderly conduct complaint which occurred in the 1100 block of Walworth Road. The complainant reported that eggs and other items had been thrown at the residence. At the conclusion of the investigation non-traffic citations were issued to two 15-year-old juveniles for disorderly conduct and curfew.

On Monday, June 17^{th} at approximately 9:10am officers received a burglary complaint which occurred at Geneva Auto Sales, N853 Hwy H. Details surrounding this incident have been intentionally withheld as this remains an active investigation.

On Wednesday, June 19th at approximately 5:33pm officers responded to the Upper Crust for a report of a vehicle doing "donuts" in the grass. At the conclusion of the investigation a 27-year-old male was arrested for operating a motor vehicle while intoxicated 3rd offense. Charges of operating a motor vehicle while intoxicated and operating after revocation have been forwarded to the Walworth County District Attorney. Additionally, the male was issued a citation for open intoxicants in a motor vehicle.

On Thursday, June 20th at approximately 11:33pm officers executed a traffic stop on Hwy 50 for a speeding violation. At the conclusion of the traffic stop a 57-year-old male was arrested for operating a motor vehicle while intoxicated 1st offense. Additionally, the male was issued traffic citations for speeding and operating after suspension.

On Monday, June 24th at approximately 12:05am officers responded to the 800 block of Juneau Road for a disorderly male subject. At the conclusion of the investigation a 32-year-old male was arrested and confined in the Walworth County Jail. A charge of disorderly conduct has been forwarded to the Walworth County District Attorney's office.

On Monday, June 24th at approximately 11:52pm officers responded to the 1300 block of Cherry Drive for a report of a hit & run crash. At the conclusion of the investigation a 56-year-old male was issued traffic citations for operating without a valid driver's license and hit & run unattended motor vehicle.

On Thursday, June 27th at approximately 10:42pm officers responded to the 1200 block of Arbutus Road for a battery complaint. At the conclusion of the investigation a 39-year-old male was arrested and confined in the Walworth County Jail. Charges of battery and disorderly conduct have been forwarded to the Walworth County District Attorney's office.

During the month of June 2019, the police department affected 179 arrests for various violations of Bloomfield Municipal Ordinances and Wisconsin State Statutes compared 166 arrests during the month of June 2018.
